# Keynote: On Library Futures and the Library's Value as Strategic Partner

Libraries stand at the intersection of technological advances, growth in knowledge and its dissemination, and post-recession budgetary constraints. Negative studies scan economic decline in libraries and offer mixed pronouncements on the value of libraries. This gloom-and-doom of the pen has heightened a sense of unease and negative self-image in the library profession. Yet despite the negative prognoses in some literature, libraries have a strong tradition of leadership in connecting learners to knowledge. Indeed, information professionals foster many of the key skills needed to sustain robust societies and economies, and the library world has many untapped opportunities for positioning itself as prominent strategic partner. How can library leaders and information professionals promote a healthy sense of value in their organization and constituencies?

In this two-part session, Part 1 will kick off with an overview of research from librarianship, economics, as well as skill-development studies from business and human resources, economics, education, and the military.

### Concurrent Sessions A

#### Cutting through the Legalese: Making Licenses in ALMA Accessible to UK Libraries

Jen Montavon-Green and Victoria Seng (University of Kentucky)

At the University of Kentucky, licenses have been stored in Alma, but accessing the terms of the license required opening the PDF attachment and reading through the license. For non-acquisitions librarians, this meant having to negotiate unfamiliar legalese to determine terms of use. In fall 2018, Victoria Seng joined the Electronic Resources Unit as a graduate assistant and began an ambitious project to add license terms into the license module of Alma.

This presentation will cover project preparation, training, workflows and customizations, problems that we encountered and subsequent follow up, as well as plans to build on this project moving forward.

#### Manage and customize Alma letters

The presentation will give an overview of Alma letter system, review letter contents and structure, discuss ways to test letters, share tips and tricks on letter customization, and lessons we learned on managing Alma letters during the migration and post-migration period.

With the new User Interface in Alma, and now the ability to edit the calendars in Excel, I'm asking for a do-over. I updated the slides to reflect the new UI and added the Excel Spreadsheet method of working on calendars. There are some tricks to be aware of when doing this work. And KCTCS entering the Alma fold helped me learn I can distribute this work across our libraries. Even if you only have one library, you can have someone else work on the calendars!
