JOHN HARPER by Ethel Stroupe Vochko, April, 1987

JOHN HARPER was born Feb. 17% (1), probably in rural Lancaster Co. PA, across the county line from Douglassville, Berks, where his parents, THOMAS HARPER and MARY STENSON had married at St. Gabriel's Episcopal Church April 16, 1754 (2). His maternal grandfather was probably a Mr. Lott because this name, not spelled the Bibical way, but with two "T's", was given to his son and passed to two of his grandsons.

In 1775, JOHN HARPER was 19 years old and single, still in his parent's home, when Capt. JOHNATHAN JONES recruited for a military company which Harper joined along with young men who became life-long friends: JOHN KAIN and ABRAHAM UNSELL. (1)

John Harper, in his pension said he was: "Born Feb. 1756, place not stated. While residing in Berks Co., PA, enlisted for a term of one year in the month of Oct. or Nov. 1775 "as he now recalls" in the State of PA as a private in Capt. JONATHAN JONES' company, in the Regiment commanded by Col. DE HAWS (DE HASS), in the Line of the State of PA in the Continental Establishment; that he continued to serve in the said Corps until sometime in May 1777, when he was discharged from said service in Philadelphia in the State of PA. That he was in the battles of Three Rivers (Canada) and at Trenton (New Jersey)." (1)

The first military groups, beginning with earliest Colonial times, were the State Militia. Terms of service in the Militia varied from three months to a year. When the Revolution began, Patriotic leaders such as WILLIAM DE HAAS of Berks Co., PA, went out and personally recruited their troops. When enough were collected, these recruits elected their officers. JOHN HARPER, JOHN KAIN and APRAHAM UNSELL were undoubtedly among the first volunteers from Berks Co., probably recruited by Jonathan JONES, being in the First Co. of the First Pennsylvania Regiment.

In April 1776, an Act of Congress formed the first federal Army, the Continental Line, with three year terms of enlistment. The First Pennsylvania Regiment became part of the Continental Line in 1776, but men who enlisted prior to 1776 were bound only to their original terms. In Oct. 1776, Co. DE HASS was appointed Continental Army Co., retroactive to Jan. 22, 1776, of the First Pennsylvania Battalion.

In JOHN HARPER'S words, he "fought as a private soldier in Canada and Trenton in Col. DE HAWS Pennsylvania Regiment...for 18 months.. " (1)

In the winter of 1775, the First Pennsylvania Regiment was in the Canadian campaign, where many lost fingers and toes to frostbite. The winter of 1776 they fought in New Jersey, many marching in the snow in summer clothes, and broken shoes. Histories say that most survivors of the Crossing the Delaware and the Battle of Trenton never fully regained their health. (5) However, JOHN HARPER parents sent him off with enough warm clothing to survive two dredful winter campaigns.

In 1775, Arnold refused to retreat from Canada, and by May there were probably 7,000 Americans in Canada. On June 9, 1776, Gen. THOMPSON took part of the army by small boats to land above the Three Rivers and to attack the enemy at daybreak where the river was very wide at Late St. Peters. They were to rendevous with troops comming overland, led by Gen. SULLIVAN, but the British fleet sailed up the St. Lawrence to Quebec, fired on the small boats and the game was up, they being cut off from the troops coming by land who had lost their way. The morale of the American Army went to

The boats were ordered to retreat 45 miles to the mouth of the Sorrel, leaving the army on foot to make their way as best they could "though Horrid Swamps on the north side of the River... where we were almost devoured by musheetoes of a monsterous size....: As they fled along the St. Lawrence, down the Richelieu back to their own country, the ravages of smallpox spread, and so, too, did other diseases. Eventually the pitiful remnants of the army found refuge at Fort Ticonderoga, where they made their stand. (6)

John was discharged at Philadelphia in May, 1777, after serving eighteen months (1). Two months earlier, in March, his father and brother Thomas had joined the Continental Line, each serving six years to the war's end. From this, it seems likely John was ill, perhaps with malaria or smallpox, and went to his father's farm to recuperate. He probably stayed on to help his younger brother, Samuel, run it, in their father's absence. This farm, be-

lieved on the Lancaster/Berks border should be where he courted his future wife.

About 1778, John HARPER married BARBARA STRUBLE (4). She was born in March 1756 (1). One documentation of her name comes from Sue Stroup Merrill: "John Harper-wife Barbara. Ky. " (6) The other documentation is an 1811 Rowan Co. Deed made by John and "Barbary" Harper. (7)

No record for their marriage is found in Berks Co. Harriages 1730-1800, which may mean the record is lost or that they married elsewhere. Marriage laws required they be performed in the bride's county of residence and there were Strubbels in both Philadelphia and Berks Counties.

In Philadelphia County in 1790, a Dr. JOHN C. STRUBBELL, and in 1785 a Jacob STRUBBEL in Amity Township, Berks. These may be Barbara's brothers, from their locations.

John Harper had three sons born in Pennsylvania from census records: DAVID in 1778, LUTTin 1781, a son SAMUEL in 1785. His last northern record is the birth @1790/1 of a daughter LUCT in Pensylvania. (8)

The 1790 Census listed many different JOHN HARPERS in Pennsylvania, but none in the eastern county with the right number of children for John and Barbara's family, which in 1790 numbered at least 3 males -lo and probably one or more daughters. The census taker probably missed them completely, because the summer of 1790 is approximately when they moved to NC.

By 1784, John's brother, Samuel Harper, owned land on the Yadkin River in Rowan Co., NC, and, by 1789 brother Thomas Harper also owned land there. They lived on Potts and Swearing Creeks in Jersey Settlement amongst English Baptist families some of whom were from northern New Jersey, around whom settled German Dunkers families from Pipe Creek, Maryland.

Some other Jersey Settlement families came from Maryland and Chester Co., PA. In 1790 the following tax district listed farmers along Potts and Swearing Creek and to the cross roads at Lexington. John Harper came here after the census, and owned land on Potts Creek near his brothers and the WHITAKERS who would become his inlaws.

The 1790 neighborhood was made up of 54 families: PHILIP BECK, MICHAEL BEARD, WILLIAM, HUGH and JOSEPH CUNNINGHAM, SAMUEL CUMMINS, JOSEPH DAVIS, WILLIAM and JOHN DANCY, JOHN GREENE, JACOB HUFF, GASHAM HUNT, THOMAS HARPER, (2 males + 16, 3 females), SAMUEL HARPER (1 male + 16, 4 females), JONATHAN HUMT, sr., JOHN HUNT, JOHN HOLLIS (a some time preacher at Jersey Baptist Church), PETER and ADAM HELMSTATIER, JOSEPH and JOHN IANNING, JOHN LOYD, BOYD, HUGH and widow MC Crary, WILLIAM KELLET, JOHN, SAMUEL and ROBERT OWEN, WILLIAM MILSAPS, FREDERICK MICHEL, ELDAD REED, GEORGE REED (Reed's Cross Roa ds), ARNOLD RUSHEN, JOHN SILVERS, MICHAEL TRACY, GEORGE THOMPSON, JOSHUA WHITAKER (wiose farm is now downtown Lexington), JOHN WILSON, HENRY and LEWIS WINKLER (who lived three miles southeast of Lexington next to BECK'S Lutheran Church PETER WHITAKER (a mile east of Lexington), RICHARD, CHARLES and BOYD WILSON, JOHN WHITAKER, and ALEXANDER and HENRY TARBOROUGH.

The Jersey Settlement listings show John Harper on p. 392. On p. 393, Thomas Harper, sr. (his father), and brothers Samuel Harper and Thomas Harper, Jr. Living nearby, Revolutionary veterans JONATHAN HUNT and DAVID ENGler, who again became John's neighbors after all moved to Kentucky. In 1800, John's son, LOTT, was nineteen, but was not listed in his father's home.

ADAM COOPER, b. 1760, Chester Co., PA, son of an Episcopal clergyman who moved from place to place, could have known John Harper when growing up in PA, especially if his father visited St. Gabriel's Episcopal Church in Douglassville, Berks Co.

However, Adam Cooper could not have known John Harper after leaving PA nor during the war. Cooper was a teenager when he settled in western NC, as the first white settler in Eurombe Co., NC, according to Bruce WHITAKER's findings (11). Cooper fought in the Revolution in a Sullivan Co., TN outfit, and by 1790, was one of Eurombe's first Justices of the Peace. @1795, he apparently went by stagecoach from Fairview to Jersey Settlement to visit Eldad Reed, a war time friend, and apparently met the three Harpers, who between them had fought in the war for fourteen years.

Cooper had been captured by the British after a sword fight in which he lost most of the fingers of his right hand along with his left thumb, and was sword-whipped across his back. These service-connected disabilities entitled him to an early pension, and Eldad Reed testified for him. The two

men lived over a hundred miles apart, served in different NC Regiments, and may have met in a British prison camp, the Reeds having come to NC from New

When Cooper visited Reed in Jersey Settlement, he probably met his new neighbor, John Harper, recently arrived from PA. Harper undoubtedly sympathised with Cooper, the reason he allowed his teenaged son, Lott Harper, to go home with him as an apprentice or hired man to "Cooper's Station" stagecoach stop, at modern Fairview, because "both the Harper and Cooper families have the tale that Lott Harper came with Adam Cooper." (1 The 1800 Buncombe County census shows a teenaged boy in Cooper's home, the right age to be Lott, and not accounted in Cooper's children (11).

A strong lad with good hands would be very useful to the badly disabled old veteran, and he is probably the one who taught him business and to distill fine apple brandy for sale to mountain taverns throughout western Carolina, a trade which added to his later prosperity.

After 1800, a wagon train of Baptist families left Jersey Settlement, for Muhlenberg Co., KY to form Hunt's Settlement in Quality Valley. Families leaving included GEFSHAM and JONATHAN HUNT, WILLIAM WILLIAMS, and DAVID ENGLER. Hunt's settlement was on Mud River which formed a line between Muhlenberg and Butler Counties. Mud River was actually a small creek, and part of John Harper's children lived on the Butler County side. At Quality Valley, these families from old Jersey Settlement Baptist formed Hebron Baptist Church. John Harper's war buddy, Abraham Unsell, was also an early Muhlenberg pioneer.

In 1807, TIMOTHY WISEMAN of Rowan Co. sold 63 acres on Potts Creek to HENRY WISEMAN, next to John Harper and John Hunt, part of land heired from . John Ford by William Wiseman, who willed it to Timothy Wiseman.

John Harper was listed on census page 282 Buncombe Co., NC, identified as Big Ivy Township, a northern location now in a national park. His son Lott Harper was listed on census page 158, living at Fairview, some miles south. In 1811, John Harper sold his Rowan land. In 1814, he sold his 250 acres at Big Ivy and moved to Mud River, Quality Valley, Muhlenberg Co., KY.

On June 2, 1818, John Harper, a resident of Muhlenberg Co., Ky. aged 62, applied for a Revolutionary War Pension, which was approved when he was 66, with retroactive payment and \$8.00 per year thereafter:

"And in pursuance of the Act of the 1st day of May 1820, I do solomnly swear that I was a resident citizen of the United States on the 18th day of March 1818, and that I have not since that time by gift, sale or in any manner disposed of my property or any part thereof, with intent so to diminish it as to bring myself under the provisions of an Act of Congress entitled "An Act to provide for certain persons engaged in the service of the United States in the Revolutionary War. And that I have not nor has any person in trust for me any property or securities, contracts or debts due to me; nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed."

"He states that he is a farmer and has no children and that no person resides with him except his wife who will be sixty-six years of age in March next."

" Schedule:

One Mare worth the value of \$60.

One Cow of the value of \$10.

One sow and pigs of the value of \$5.

Sworn to and declared on the 2nd day of April in open court. John Harper (not with X)

"He fought as a private soldier in Canada and Trenton in Col. De Hass' Pennsylvania Regiment, Capt. Jonathan Jones' company. John Harper served 18 months and was discharged in 1777 at Philadelphia. He was given discharge papers, but in 1818 said he had misplaced them. (4)

John's brothers, Samuel and Thomas Harper, moved to NC, to Jersey Settlement, on the Yadkin River, a settlement primarily of English Baptists and German Dunkers, around modern Lexington, NC, old Rowan. Here in 1784 Samuel Harper married Mary Ford and lived on Swearing Creek. In 1789, Thomas Harper married Sarah Wilson and lived on Potts Creek. (6)

About 1791, John and Barbara Harper joined his brothers at Jersey Sett-lement, bringing older children, including David Harper, about 13, and Lott Harper, about 10 and unidentified daughters. His father, Thomas, Sr., probably also accompanied him. At Potts Creek, John and Barbara had more children. They belonged to Jersey Baptist Church, as did neighbors Eldad Reed, Johna Whitaker, John and Jonathan Hunt, William Williams, and David Engler.

About 1804, Lott Harper married Miriam Whitaker, daughter of Peter Whitaker and wife Miriam Kent, who had moved from Jersey Settlement to Cane Creek, Buncombe. Lott and Miriam Harper lived on Fairview Road, next door to Adam Cooper. His home was across from Modern Fairview School, a site now ident-ified by a grove of tall cedars.

After bearing many children, Miriam died, and Lott married her sister, Susannah Whitaker, who raised the children but had none of her own. Lott's daughter, Susannah Henry and her husband lived about two miles down Cane Creek from his Fairview home, and were "close" to him.

About 1801, Thomas Harper, Sr., moved with his daughter and son-in-law to east TN.. Thomas Harper, Jr., also moved to TN, then to Kentucky, then to Alabama. Samuel Harper moved to Jasper Co., GA. (3)

The third brother, John Harper, moved to Big Ivy, Buncombe Co., NC before the 1810 Census and selling out in 1814. He then moved to Kentucky following his son, David Harper, and former neighbors from Jersey Settlement. John Hunt, David Engler, and William Williams. These families settled in Quality Valley, Muhlenberg Co., KY, where they founded Old Hebron Baptist Church. (8) Church. (8)

In 1818, John Kain of Knox Co., TN, made an affadavit in open court at Knoxville, he was well acquainted with John Harper in Berks Co., PA in 1775, 1776. 1777, when he served from Berks Co., PA.

In 1821, the Muhlenberg Co., Court noted that John Kain of Knoxville was "Now deceased." He received \$321.80, in arrears to Sept. 4, 1821, after which he received \$8.00 per month.

Although he may have lost fingers or toes to frostbite at Quebes or Trenton, John Harper was apparently not seriously wounded in battle, or else he would have been eligible for pension before the Congressional Act of 1818. at which time men became eligible who could prove financial hardship. (5)

The death of Revolutionary pensioner John Marper on Sep 11, 1834 was reported to the Muhlenberg Co., Court, which appointed his friend, David Engler, administrator, and Elijah Hunt, William Williams, Jonathan Hunt and Abel Penrod "any three of them" to appraise his personal property, (7) (this estate record has been transfered to the KY State Archives in Frankfort.)

Barbara Struble Harper may have survived her husband by several years, dying about 1837, at which time their real property would be divided among heirs. I believe Lott Harper again sent his son-in-law, Ephraim Henry, to KY about an inheritance, and that Ephraim Henry died on this trip: by 1838 Susannah Harper Henry owned Ephraim's Cane Creek Farm and was free to Marry Silas Stroup, son of Joseph and Catherine Creasman Stroup of Bull Creek.

John and Barbara Harper's graves are not at Old Hebron Baptist Church and are probably on their farm in quality Valley. The Asheville D.A.R. put Lott Harper's name on a Court House monument honoring Revolutionary Soldiers of Buncombe, the soldier being his father, John Harper. Apparently the tales of the three Harper men having served a total of fourteen years in the Revolutionary War was handed down, but by the 1930's Lott was confused with his father.
