BAALAM JONES VS ALFRED PAYNE

BAALAM JONES VS ALFRED PAYNE, &C
CASE NO 689 - Filed Nov Term 1835
Barren County Kentucky Circuit Court
Change of jurisdiction from Allen County, Kentucky
Original bill filed Allen County, Ky., 23 November 1826

To the Honorable, the Judge of Allen Circuit Court in Chancery sitting, your Complainant Balaam Jones respectfully sheweth unto your Honor that sometime ago he unfortunately became involved as the surety of his son Daniel M Jones, to a large amount, and he has been compelled to pay and advance for said Daniel M Jones a considerable amount of money that the said Daniel M has been unable to refund, and that Daniel, in part payment of the losses sustained by your Orator proposed to sell and convey to your Complt a certain lot of ground with it's appurtenances, lying and being in the town of Scottsville, and known and designed in the plan or map of said town as lot No 11, and your Complt, believing he could do no better than to take it, agreed and did take it at the price of One Thousand dollars, and Daniel M Jones, on the 15th of March 1822, executed to your Complt an instrument of writing which your Complt believed to be to all intents and purposes, a good and valid indenture and conveyance for Lot No 11.

But your Complt has recently discovered that said instrument of writing, although it was duly proven and admitted to record in the Allen County Court Clerk's office, yet that it wants a seal, and cannot on account of that difficulty be received and admitted as a deed of indenture, but is only operative as a title bond, by which your Complt is advised that he can complete his title to the lot.

Your Complt is further advised that a certain Alfred Payne claim title to said lot under a pretended purchase under execution against the estate of the said Daniel M Jones on the 27th June 1823, and that he has since, on the 10th July 1823, made a pretended mortgage of said lot to William R and Tully R Payne.

Your Complt charges that previous to the said Alfred Payne's buying or pretending to buy said lot, he was fully apprised and acquainted with your Orator's claims and title to said lot of ground, and in fact actually saw the aforesaid instrument of writing from said Daniel M Jones to your Complt . . notwithstanding he may have received from the Sheriff a conveyance for the said lot, and thus apparently have acquired a legal title, he is advised and charges it is inferior to and must yield to the superior equitable claim of your Orator.

Your Complt charges that even if the said William R & Tully R Payne at the time they may have received (if they ever did receive) the said pretended mortgage from said Alfred for said lot, were ignorant of your Orator's claim, yet deriving title from said Alfred,

their claim must also yield to your complainants.

Your Complt further charges that said Alfred's pretended purchase of said lot under the execution was made the 27 June 1823, yet never obtained a conveyance from the sheriff until the 28 Oct 1826, which was acknowledged in the Clerk's office on 21 Nov 1826, that Alfred, William R, and Tully R Payne all along since have known of the claim of your Orator, and are purchasers with notice, and that your Complt instituted an action of ejectment in the Allen Circuit Court at the November Term 1826, when the jury were sworn, the foresiad instrument of writing from Daniel M Jones to your Complt was rejected as an instrument because it was destitute of a seal.

Therefore your Orator prays that said Daniel M Jones, Alfred Payne, William R Payne, and Tully R Payne be made defendants to this bill, and they be compelled upon their oaths, true, distinct, and perfect answers to make to all and singular the allegations in this bill, and that upon a final hearing the said Daniel be compelled to convey title to your Orator, and the others relinquish their claim to said lot of ground.

Your Orator herewith exhibits, and prays the same to be made a part of this bill, a copy of the patent from the Commonwealth of Kentucky to John Brown for 200 acres of land dated 21 December 1815, and marked "A" and which included the lot in controversy, and the land upon which the town of Scottsville was established; a copy of the deed from said Brown to the Trustees of Scottsville dated __day of _ and marked "B"; a copy of the deed from the Trustees of Scotts. ville to James Cowden for said lot dated 10 February 1816, and marked a copy of the deed from said Cowden to said Daniel M Jones for said lot dated 2 December 1816 and marked "D"; and the aforesaid bond or instrument of writing from said Daniel M to your Complt for said lot dated 15 March 1822 and marked "E". Your Orator also files copies of the various orders of the Allen County Court establishing and relating to said town of Scottsville marked "F", and refers to the Act of Assembly of Kentucky, establishing the County of Allen. All of which shew and prove your Complt's title to said lot of ground,

REVISED BILL FILED 22 Aug 1827

Your Orator Baalam Jones would represent to your Honor the Honorable Judge of the Allen Circuit Court that since the filing of the original bill, the Defendant T R Payne has departed this life on the day of 1827, and has left an only child, an infant by the name of Mary Frances, and his widow Catherine, who is also Co-Administrator with Edmund Payne of the estate of s'd deceased. He prays that said Bill may be served against s'd Mary Frances and Catherine & Edmund (Payne), and they be made defendants upon all the allegations in his original bill.

WM R PAYNE - ANSWER - Filed 22 Aug 1827

The separate answer of William R Payne to a bill in Chancery exhibited against him & others in Allen Circuit Court by Baalam Jones. This Respondent, now and at all times saving to himself all benefit of exception to the many errors &c in said bill contained, for answer

to so much thereof as he is advised is material for him to answer, says that he herewith files the mortgage made to him and Tully R Payne, who since has died, bearing date 10th July 1823 - that the mortgage was executed in good faith, and that the sums of money mentioned in the mortgage are jointly due from Alfred Payne to this Respondent and said Tully. Your Respt insists that he and said Tully are bona fide holders of the lot mentioned for the purposes in the mortgage, and denies that Complt can divest them of their title - this Respt knows nothing of the advances which Complt says he made to his son Daniel, and requires full proof. He denies that he knew of the Complt's claim to the said lot, and has no knowledge of the allegations of the Complt, and requires full proof of them ... /s/ Underwood, Atty

ANSWER - DANIEL M JONES - Filed 21 August 1827

State of Kentucky - County of Simpson - This day Daniel M Jones appeared before me, a Justice of the Peace for said County, and made oath the matters and things contained in this statement are true of his own knowledge. Dated 11 July 1827 - s/s H B Montagin, JP

The separate answer of Daniel M Jones to a bill in Chancery, etc Saving and reserving to himself, etc. . . saith that he was justly indebted to the said Baalam Jones upwards of Two Thousand dollars, for which his father Baalam Jones held his note (the amount was say, about twenty four hundred dollars) the greater part of this was for money actually loaned to your Respt by Complt, that he became embarrassed and unable to pay the debt in money, and the said Baalam, becoming uneasy, your Respt proposed to pay him partly in property to be valued to him, which proposition Baalam accepted, and according ly the house and lot was valued at the price mentioned in the deed exhibited by Complt, and Deft accepted it. Your Respt executed the said instrument of writing intending it to be a sufficient deed of conveyance for said house and lot, that it was executed on the day it bears the date, fairly and bona fide, without the least intention o f defrauding anyone, and with the sole intention of discharging an honest debt due. Your Respt is willing that all the papers be exhibited by Complt, and if necessary, if the deed proves insufficient, to make a sufficient deed, and he prays to be henceforth dismissed.

ANSWER - ALFRED PAYNE - Filed 18 Sept 1827

State of Kentucky - Allen County - This day Alfred Payne appeared before me, an acting Justice of the Peace for the above County, and made oath that the statements made are of his own knowledge, etc.

The separate answer of Alfred Payne to a bill - saving to himself all benefit . . . says that he knows nothing of the monies paid or advanced by the Complt Baalam Jones for Daniel M Jones, nor does this Respt believe that he has been compelled to pay any considerable amount for him. This Respt has been informed that the Complt, by way of advancing to his said son in the commencement of his caree in life made a donation of a tract of land to him, which land has been sold and the said Daniel has had the use of the proceeds, and this is made the pretext on the part of the Complt to cover said

Daniel's property from his just creditors, as your Respt believes. Your Respt knows nothing of debts which Complt has paid as security for said Daniel. It is true that your Respt purchased the Lot No 11 in the bill mentioned under an execution against said Daniel, and herewith files a copy of the execution, under which he purchased the lot. The executions mentioned in said record which was never returned to the Clerk's office of Simpson County Circuit Court, was the execution under which the land was sold, and that execution was sent by mail by the Sheriff of Allen (County) but never reached the Clerk of Simpson. Your Respt herewith files copies of his deed from the Sheriff of Allen (Co) dated 28 Oct 1826, for said Lot No 11. He states that he has a fair title to the lot and has made lasting and valuable improvements of same. He denies that the mortgage was made for any fraudulent purposes - admits that before he purchased the lot he understood that the Complt pretended to claim the lot, but his claim was spoken of by others who conversed upon the subject as being fraudulent. He admits that it was some time after he purchased the lot before he got his deed, but it was owing to the loss of the execution under which the lot was sold that he could not get the deed sooner, not knowing well what to do after the execution was lost.

As evidence that Complt Baalam Jones claim is fraudulent, your Respt states that on 15 March 1822, as will appear from the copies of the record of the Simpson County Court herewith exhibited, the said Daniel M Jones conveyed or pretended to convey to his father, the Complt, all his property, copies filed herewith marked, 1, 2 & 3, all dated 15 March 1822, and the consideration of all amounting to upwards of \$1800., & it seems that that sum has actually been paid by said Daniel to said Complt in property amounting to the value of it, and this Respt would like to know how the Complt paid that sum to his son Daniel, and also \$1000. over and above for the lot in Scotts-ville.

Your Respt charges that these conveyances were fraudulent, and states that a few days after said pretended conveyances, Creson, Wister & Co instituted suit against Daniel in the Simpson Circuit Court for \$400. and upwards on a note, and your Respt believes that Daniel, in anticipating said suit colluded with his father and made the conveyances to him to defeat the judgement which might be rendered, and herewith files a transcript of that suit of said Creson, Wister & Co against said Daniel Jones. After the judgement was obtained the execution was levied upon the land, towit, 150 acres pretended to be conveyed by Daniel to Baalam, a jury called to try the right of property, who found it subject to the execution, and then the said Baalam replevied the debt as one of the securities, such is your Respt's information.

Thereafter said Daniel sold, used, and converted the property mentioned, or a considerable portion thereof to his own use, and he continued in the possession thereof after the said conveyances were executed. Prays that this bill be dismissed, as the Defts claims are untrue, and fraudulent claims have been made.

JONES BILL OF SALE TO JONES - Exhibits No's 1, 2, & 3.

No 1 - Daniel M Jones, of Simpson County Ky, for \$632. in hand paid by Baalam Jones, sold to Baalam Jones all the goods, household furniture hereinafter mentioned: two beds and bedsteads and all the bedclothing thereunto belonging, two bureaus and a book case, 3 tables and all my Kitching furniture, one large looking glass, four volumes of Settle's laws, twelve volumes of the English encyclopedia, two volumes of Chistifield's letters, two volumes of the manners and customs in nations and Vattels law of Nations, two stills, two worms and worm tubs and twenty four beer tubs, Eight hundred staves and a parcel of corn supposed to be thirty Barrells, twelve barrells of whiskey, Eighty head of hogs, fifteen head of cattle, a truck waggon, a man's saddle and a woman's saddle, six hundred weight of bacon, and To have and to hold all and singular the said goods, two bridles. . . . this 15th day of March 1822. /s/ Daniel M Jones Test: H R Williamson & George Allen. M M Martin, Deputy Clerk, Simpson County (Ky) certified the instrument by Daniel and the witnesses. dated 11 April 1822. Enoch ? Moore, Clerk certified the document as a true copy, 20 July 1826.

No 2 - Daniel M Jones, of Simpson County, Ky., for \$200. in hand paid by Baalam Jones, sold to Baalam a negro girl named Etny, aged nine, until the death of Thomas Lewis of Nelson County, Ky., at which time said girl Stny is to be returned to said Thomas Lewis estate to be divided amongst the Legatees of said Lewis by express agreement between said Daniel M Jones and Thomas Lewis, from whom said Jones derives his title as aforesaid to said negro.

George Allen - M M Martin, Deputy Clerk, recorded bill of sale dated 11 April 1822.

No 3 - 15 March 1822, Daniel M Jones of Simpson County, Ky., for \$1000. in hand paid by Baalam Jones sold to Baalam Jones 150 acres land on the Waters of Sulphur fork of Drake's Creek in Simpson Co Ky, boundary lines mention Jessee & William Hunt's line; by John Lewis' Still house; a corner deeded to John R Jones; thence a lane between John Lewis and Daniel M Jones. /s/ Daniel M Jones Same witnesses and recording dates as above deeds.

SHERIFF DEED - To Alfred Payne - Filed 21 Nov 1826.

This indenture made and entered into the 28th day of October 1826, between Thomas Sutton, Deputy for David Harris, Sheriff of Aller. County Ky., of the one part, and Alfred Payne of the town of Scotts-ville, Ky., of the other part, Witnesseth: That whereas the Simpson County Circuit Court did at their April Term 1823, in a suit wherein Alfred Payne, Plaintiff, and Daniel M Jones, Defendant, on a motion, rendered against Daniel M Jones judgement as per record, that on the 14th day of June 1823 execution for \$142. with interest from the 13th March 1820 till paid; and \$5.88, and \$15.25 Costs was issued thereon directed to the Sheriff of Allen County (Ky), which came into my hands and which execution I levied on one house and Lot number Eleven in the Town of Scottsville, which was according to law duly advertised, and on the 27th June exposed to sale the house and lot, and Alfred

Payne being the highest bidder became the purchaser of the whole for \$50. After deducting the Sheriff's commission thereof, leaves a balance of \$47.50, after which I conveyed all the right and title to said Alfred Payne, which the foresaid Daniel M Jones holds and has in said house and lot No 11.

David Walker, Clerk of Allen County, Ky., certified that the above is a true copy and was produced to him for record on the 21 day of November 1826

SUMMONS - Dated 29 Nov 1826 - To the Sheriff of Warren Co Ky - for Daniel M Jones, Alfred Payne, William R Payne, and Tully R Payne to appear the first day of the next May Term Circuit Court - noted that the Sheriff of Warren County (Ky) will execute on William R Payne and Tully R Payne, process having issued to Nelson and Allen Counties against the other Defendants. Noted - executed on W R & Tully R Payne the 21st April 1827.

LETTER ADDRESSED TO - Mr Richard C Craddock, Cynthiana, Harrison Co., Ky., from Sam'l Brents - dated 2 April 1828 - Greensburgh (Note: this evidently Greensburg, Green County, Ky.)

Dear Sir: I shall shortly go to the Springfield for among other things to attend to the case between Robert Craddock & yourself, Mr Hardin must however be principally relied upon he attending the court regularly & myself only Casually. It is important that you be there next court and see Hardin. An amendment should be made to your bill and which cannot be made in your absence. The case is of too much importance to be neglected. The Sum is now large & your friend Mitchell is involved. I gave Hardin an amended bill which Jones drew & which I never Could ger leave in the Court to file. Hardin has very likely lost it by this time and it Can only be replaced by your presence. Court Commences there the 1st Monday of Next Month - May. Do not fail to attend. I shall be there about the middle of that week & from that time until the end of the week but no longer.

You will see by the enclosed Spa you are required to answer the cross bill in the Barren Circuit Court (Ky). Acknowledge the Spa & f rward it to me by mail. You also promised me you would sign and swear & forward the Answer I sent you saying it was all right. Be kind enough to do that with all practicable dispatch & also enclose it with the Spa. Your friends (if so they may be called) here do not recognise your having made a deed to Z C for that land, nor is there any disposition to give you credit for it. The sooner you comply with this request the better. I hope you and family are well & that you will yet prosper in the world & finally go to Heaven, Amen.

ANSWER - EDMUND PAYNE - Filed 21 May 1828

The answer of Edmund Payne, Administrator of Tully R Payne, deceased, says as administrator he has no knowledge personally of the transactions brought before the court, and therefore requires full proof of all the allegations of the bill.

SUMMONS - Dated 6 May 1828 - To the Sheriff of Simpson County, Ky.

To summon Will C Bradburn, Jas Martin, John A Martin, John Lewis Sr and Mary Lewis his wife, Geo Allen, Turner Allen, Charles Wright, Achilles Hopper, and Joseph Anthony to appear at the house of Will Bradburn on 16th May to testify in behalf of Alfred Payne in a matter in the Allen County Court. (Note: on the back of the summons they all acknowledge receipt of the summons).

<u>SUMMONS</u> - Dated 21 May 1828 - To the Sheriff of Warren County, Ky. To summon Catherine Payne wife of Tully R Payne Dec'd, Edmund Payne, and Mary Frances Payne to appear in court in Allen Co Ky on the 1st day of August Term next. Acknowle dge receipt on back of summons.

DEPOSITIONS - Dated 16 May 1828

The <u>deposition of John Lewis Senr</u>, taken at the house of Wm C Bradburn in the County of Simpson Ky. Upon being questioned by the Defendant replied that he had been acquainted with Baalam Jones and his son Daniel about thirty years, and knew about Daniel having sold his property to Baalam Jones his Father, that he was informed by Mr George Allen who is now dead, that he was a witness to some writing between them to that amount, that George Allen had told him the amount claimed was six or seven hundred dollars, and that Baalam Jones stated that it was about seven hundred dollars, that he had no knowledge of any amount that Daniel owed Baalam.

Upon the question of how far he and Baalam Jones lived apart, stated that it was not one quarter of a mile, that he thought he should have known about it if Baalam Jones had paid any considerable amount to his son Daniel M Jones for property on 15 March 1822, but he knew of none. Stated that Daniel Jones had property at that time, a negro girl named Etney and 150 acres land for which he gave \$1100. in Nelson County Ky, both worth about \$1400., and that he understood that that all the interest Daniel had in the negro girl was transferre to his Father 15 March 1822; that Daniel had purchased the land in Nelson County on credit in part, and the deed was not to be made until the land was paid for, that he believed that the title to the land was not made to Daniel previous to the 1st October 1822.

The <u>deposition of Turner A Allen</u> taken at the same time and place Stated upon being questioned that he was acquainted with Daniel in the year 1822 that he lived with Daniel in the years 1822 or 23, and the time was about two or three months, and that Daniel took with him such household furniture and stock, etc, that he had in his possession when he moved to Nelson County, that as far as he knew the most of all the things were in his possession previous to 15 Mar 1822 that he did not know of his own knowledge, but was told that all the estate of Daniel, both real and personal, was conveyed to the father

of Daviel, Baalam, and that he was present when a trial took place about the property, and the jury found the property to be that of Daniel's - the best he could recollect the trial took place in the summer of 1822.

The <u>deposition of James Martin</u> taken at the same time and place, stated that in the winter of 1822 or January 1823 he purchased pork to the amount of \$52. from Daniel, but do not know whether he raised it or not, he told me that they were young hogs that he had raised. In answer to the question as to whether he had purchased beef from Baslas Jones and paying him \$20. for same, and if Daniel M Jones had told him that he, Daniel, had sold to Henry R Williamson the same beef, not knowing that Baalam had made the sale to you, and wished you to give up your claim to the beef - answered that he did purchase a beef of Baalam Jones, and Daniel did apply to him to give up his contract with Baalam, but that he did not as he had already paid Baalam for the beef.

The deposition of Mary Lewis taken at the same time and place. Stated that she lived not exceeding one quarter of a mile from Daniel M Jones and Baalam Jones in the year 1822 when they lived in this county, that she did not know of her own knowledge, but had heard that Daniel M Jones had conveyed all his property to Baalam Jones, that she had a conversation with Mr George Allen who is now dead, and the he had stated that he had witnessed some writings and went with Daniel M Jones to Franklin (county seat of Simpson county) on the same day he witnessed the writings, in company with Henry R Williamson, one of the other witnesses, and proved the same. My husband John Lewis did hold a note on the said Daniel M Jones, which note he let Mr John L Moore have some time in March 1822, and I understood that a judgement was obtained on the note against Daniel at the April Circuit Court 1822. I understood that Daniel owed money to Baalam for \$400. and wheat and tobacco sold by Baalam, and Daniel got the money for the wheat and tobacco. Answered to a question by Baalam if he had brought a very full load of household furniture with him when he move to this county, answered that he had.

To a question by Daniel M Jones, answered that she remembered some of the furniture mentioned in the mortgage, and that she understood that Tucker W Williamson got one of the said Bureau's, and Herri R Williamson got the other and a book case, and Mr Joseph Anthoni got a table, but do not know who they bought them of.

The deposition of Charles Wright - taken at the same time and place stated that he was well acquainted with both Daniel M Jones and his father Baalam Jones, that he was summoned as a witness at a trial and the property was claimed by Baalam Jones. That he had been in a conversation with Henry R Williamson regarding Daniel M Jones conveying his property to his Father to avoid the payment of the \$412. note which John Lewis let John L Moore have, and Williamson told me that Daniel told him that he was not able at the time to pay the note and that he knew that they would have to sue Lewis after they could

make nothing out of him, Daniel, and by that time they could get a judgement against Lewis, then he would be able to pay the debt, and that was the reason that he had made the conveyances. Stated that at the trial the jury had found the property to belong to Daniel M Jones; that he had bought some pork and a cow of Daniel, and thought it was the property of Daniel. He also stated that Daniel M Jones had two stills which he carried on in the years 1822-23, and afterawrds sold them to Tucker Williamson, and believed they were the same that Daniel owned 15th March 1822. That Henry R Williamson as he was informed by Williamson himself, was living in the State of Indiana in the year 1826, and he lives there yet. /s/ Chas Wright

The <u>deposition of Joseph Anthony</u> - taken at the same time and place. Stated that in the latter part of the year 1822 or the fore part of the year 1823 he had purchased from Daniel M Jones one folding leaf table, Bureau and book case for which he paid \$30. Commonwealth paper, and that he took the property to be that of Daniel's notwithstanding the conveyances. That he had passed by Daniels in the summer of 1822 and Daniel offered to sell me his stills, and that in the fall of 1822 he could sell me 2000 or 2500 weight of pork, and that he also wished to pay me what he owed me, and would be glad if I would take some property from him; and he believed them to be the same as mentioned in the conveyances. /s/ Joseph Anthony

The <u>deposition of William C Bradburn</u> - taken at the same time and place. Stated that some time in the year 1823 he became indebted to T W Williamson for a sorrel horse priced \$150. due by note March 1825, which note was assigned to Daniel M Jones. There was a suit brought on the note after assignment by T W Williamson to said Jones against myself and my surety John A Martin, which we have paid, and he never knew of any claim on said Jones property until lately. Also stated that Tucker Williamson had not lived in this state for several years.

A dear friend has sent me some excerpts from an article you published in January 1976, concerning the Smith-Campbell-Jones family. It was written by a John C Smith. I am particularly interested in that portion of the article dealing with Martin Jones, sonce I am directly descended from Martin Jones thru his son Stephen Mitchell Jones, my great great grandfather.

All my life I have heard the story of how Martin Jones was murdered in the woods of Kentucky while trying to set up camp for the night, but was unable to prove it, or to locate exactly where it happened. The article you published has gone a long way toward helping me prove that this was indeed no old wive's tale. My grandmother, Mrs Hattie Jones Ruhsenberger, told me, indeed she wrote it down, that her grand father Stephen M Jones said his father was murdered while asleep wrapped up in a blanket by his campfire. He had gone to a cabin while traveling and asked for fire, or to spend the night, or something like that, and the woman there said her husband was extremely jealous and she could not let him spend the night in case the husband, who was also away, would return and find him there, but she did agree to give him a blanket or a quilt. The husband did return, and recognizing the spread, shot Martain Jones, without ever seeking to know why he had that particular spread. The story is somewhat different in small matters, but the names are identical to those in my family and the story so incredibly similar that I feel they are one and the same.

My Stephen Mitchell Jones was born in Kentucky in 1802, moved to Indiana around 1835 or so, to Spencer Co., first, then on to Crawford Co., where he remained the rest of his life. He was a shoemaker and died in 1883. His first wife, whom he married in Kentucky was a Mary Bush. His brothers were Lewis and William. His sons were Isaac James, Stephen, Bruler, Benjamin, Lewis, and Robert Owen, my great-grandfather. Lewis Jones, the son, left a son named Martain Jones (1872-1945), who is buried in the English, Indiana, cemetery, as is Lewis Jones, the brother, who was born in 1798 and died in 1882. Stephen Mitchell Jones is buried in a small cemetery in Grantsburg, Indiana, next to his second wife, Eliza Anderson Jones.

The Martain Jones mentioned in the article was the son of Isaac Jones, who was probably from Bedford Co., Va and according to family tradition was killed by Indians in Tennessee.

I hope this will shed some more light on an incident in early Kentucky history that will be just as interesting to others of your readers as it has been to mo. 10/s/Ann~H Stewart

EMBREE, EMBRY, EMERY, EMBRE, EMBURY and EMBROUGH

Embreys were probably German Protestants. The first person we know of with that name in the U.S. was said to have come over on the ship named "Perry". Those in Alabama probably descended from John Embrey of New York (1700) who had a brother named Phillip. Some researchers reported that they started the first Methodist Church in New York City in 1760 but that is not a proven fact. In 1682 Moses Embrey lived in Hempstead, Long Island.

In 1761 Joseph Embrough bought land on Neuse River in North Carolina. Eighteen years later Thomas Embrough bought land in the same area. There were land grants to Joseph and Thomas Embrough in the township of St. Matthews, Wake Co, N.C. Thomas may have been a son of Joseph. Their neighbors included a family named Olive.

Thomas' wife's maiden name was Jackson. He died in Wake Co., N.C. in 1795 and the settlement of his estate is shown in the clerk's office book #3, pages 34, 163, 210 and 211. His children were: Anna Embrough Dow, Boley, Thomas, Robert, Joseph, William, Reubin and Enoch.

Records show a land grant to Thomas Embrough, 640 acres in North Carolina on both sides of Beaver Creek, entered August 18, 1778, book #31, page 340 and 240 acres on the south side of Neuse River, January 8, 1779, book #39, page 137. In the 1790 census of Wake County, Thomas and William Embrough are shown as heads of families in the Hillsborough district.

It seems that Thomas' son Reubin, Thomas, Boley and Joseph went to Tennessee. Other Embreys shown as Tennessee soldiers in the war of 1812 were: James, Joel, Murray and Jessee. Records of Enoch Embrey can be found in both Georgia and Tennessee. He was in Georgia by 1790 and married by 1804. We found no proof that he was a Revolutionary soldier, but he must have helped the government some way in order to be entitled to a land grant, and may have furnished food or supplies and been classed as a Soldier of the Line.

Boley Embrey may be found in the Franklin County, Tennessee Will Book #1808-76-107, August 27, 1832. His children were: William, Isaac, Thomas Jefferson, Elizabeth, Isabelle, Jenny Matilda and Lucy. Thomas Jefferson and his wife Sarah had a son James Boley.

Thomas Embrey in 1811 married Nancy McElroy in Oglethorpe County, Georgia. Their children were: Elijah, Joel, Sarah, Mary, Josh, Martha, and Thomas. They also had a grandson Benjamin F Eastiff.

Joseph Embrey married Rachel Olive and had a son Elijah. The children of this Elijah were: Joseph H., Jesse C., Martha, Mary, Elizabeth, A.J. and James. This James was in the Battle of Horseshoe Bend and had a son James Alden (1860-1953). Joseph H. was buried at Shilo Baptist Church in Coosa County, Alabama, along with Joseph and Sarah Tuck. He was 97 in 1850. James Alden had five children: James B., Joseph, Eugene, Frank and Harriett.

John Embrey's children were: Hezekiah, Boley, Elizabeth, Delila Charlotte, Sally and Synthia.

William Embrey and his wife Frances had children: Joel, Thomas, John, Nancy, Susannah Johnson and Tilly Griffith.

Enoch Embrey made his will in 1852 and it was probated in 1856 in Tallapoosa County, Alabama. His children were: Enoch Jackson, Elijah Thomas, Ann, Mary, Martha (Patsy), Lythis (Cynthia), Elizabeth (Betsy), Talithia, Henry Tillman, Richard and Rebecca.

Enoch Jackson married Margaret Isabelle McClure who died in Red River County, Texas. Elijah Thomas married a Smith and had twelve children. Ann married John Hartsfield and had: Warren, Jay, Louise Moore, Sarah Ann McCall, James and Jane. Mary married a Williams and had two children. Patsy married a Lassiter and died in 1864. Cynthia married Ronald Jackson. Betsy never married. Her will was probated September 17, 1860 in Coosa County, Alabama, leaving her estate to Anna Hartsfield, Jackson Embrey and James Newton Williams. Talitha married a man named Driver.

According to family information Enoch Jackson Embry married Margaret Isabelle McClure in Georgia. They moved to Texas where she died and Enoch brought his four small children back to Alabama in an ox wagon. The children were: John, Alex, Mattie and Dollie. Enoch Jackson's sister Patsy Lassiter took Dollie to Pike County, Georgia, and his other sister Ann Hartsfield took Mattie and Alec.

John Embry, the oldest of the children, was born in Pike County Georgia, July 10, 1848 and died in Coosa County, Alabama February 24, 1928. He was a veteran of the Civil War, fought in the Wilderness Battle, Battle of Cowpens and Battle of Gettysburg. He was under the command of General Robert E. Lee. His outfit was captured in Virginia. He was in prison at Lookout then was sent to Mobile.

I have just learned from a resident of Harlan, Kentucky, the history of a man whose longevity reminds me of the great Thomas Parr, whose remains lie buried in England's famous channel house, Westminster Abbey, for no other reason that he was the oldest man Great Britian ever produced, and there was no cause to think that the "Old World would ever look upon his like again."

The aged Kentuckian in question was GEORGE BURKHEART, and one of the most remarkable things in connection with his history is that it has never been published. But Harlan County is in the mountains, and does not possess one of those professional newsgatherers, a newspaper. BURKHEART was born in Germany in the year 1735. Soon thereafter he proceeded to Virginia where he married. This union produced him five children, and his wife died. He married again and in the year 1880

he five removed to Kentucky. He settled on Crank's Fork of Cumberland River, fourteen miles south of Harlan courthouse, and with his family took shelter in an enormous sycamore tree. By the way - Harlan County is not wholly unlike the big-tree district of California. This tree was forty-five feet in circumference, and necessarily fifteen feet in diameter. In this romantic abode he and his wife and the five children had beds, tables, chests and such other furniture as a wild-mountain home usually contains. Although the frosts of seventy-five winters rested on his ample brow, he did not neglect that part of the Divine injunction which says: "Be ye fruitful, multiply and replentish the earth," for when the requisite years had flown he was found to possess by the second wife eight children. In the meantime he had built a cabin and acquired 1,400 acres of good land, and was one of the solid men of the country.

His second wife died and after a short period he went to Virginia, that generous old State that had already furnished him two helpmates, and he married a third time. Her name was ELIZABETH GRABILL, and she resided in Lee County. Mr BURKHEART was now a centenarian. He repaired to his cabin beside the faithful old tree, where they lived happily for five years; and, it is said, a child or two were born. This third "better half" of the old man died at the good age of 70. The grief-stricken husband bewailed her loss even more bitterly than those who had gone before her. But, his days of sorrow were not many. He soon turned out to the "log rollings" and "quiltings", which fashionable pasttimes were frequent in their occurrence, and danced with the girls, entertained them with his comic songs, and was a gay old deciever, as giddy as a girl of 15.

In the yaer of 1840, at the age of 110 years, he married a fourti The name of this last wife was LAVENIA MORRIS, and her age The immense disparity of age, seventy-five years, worked harm. Dissentions arose and a separation followed. No children blessed this union, and as all his others had become grown or died, the patriarch was left alone in the cold world. His days of frivolity he now considered over. He was too old to trudge about his mountain farm, so he applied more closely than ever to his favorite pursuit, that of a sorcerer. For miles and miles around his powers were recognized. Even in far-away Tennessee and Virginia, people who were troubled with witches and other unseen and direful enemies, applied to him for relief. His magic wand was invincible. Bewitched stock and dogs and cats, as well as human beings were made whole through his influence. Diagnosis was a matter of but a moment's glance with Occasionally a case was so stubborn that heroic treatment became necessary. This treatment consisted in drawing a picture of the particular witch that was ruling over the patient. This picture was pasted on a tree at ten paces, and with an old-fashioned long squirrel rifle he would send a bullet crashing through it. The shot destroyed the witch, and the patient was free. Sorcery was a considerable source of revenue to the old man.

Mr BURKHEART spoke German to his children, and bad-English to others. His education was slight. He was a man whose word was as

derful old man died in the year 1850 at the great age of 125 years. He had a son who lived to be 90. Judge Noble Smith, Mr G B Turner, and other good citizens of Harlan knew BURKHART, and testify to the facts in this statement. Two persons recently died in that county aged 98 and 100 years respectively. Several more reside there who are equally as old. It is thus seen that the late Dr Graham of Louisville (Ky), who celebrated the anniversary of his one-hundredth birthday, was not the only centenarian in Kentucky.

This Indenture made this Twentyeth Day of November in the year of Our Lord one thousand seven hundred & ninety nine between Joseph Crockett & Elizabeth his wife of the County of Jessamine & State of Kentucky of the one part & William J Wood of the County of Barren & State aforesaid of the Other Part. Witnesseth that the said Joseph Crockett & Elizabeth his Wife for & in consideration of the sum of two hundred pounds current money of Kentucky to them in hand paid the Receipt Whereof they do hereby do Acknowledge, have granted, Bargained, and Sold, and by these presents do grant, Bargain & Sell unto the said William J Wood his heirs & Assigns forever A Certain tract or parcel of Land containing by Survey two hundred & fifty Acres lying and being in the County of Barren & bounded as followeth towit:

Beginning at the lower end of the second bottom below Richard Clark's lower Survey on Green River At a white Oak tree marked R F, and spanish Oak standing on the side of the River hill Thence Running up the Mavenders of Green River And binding thereon (Towit) North thirty degrees East seventy nine poles North twenty degrees east two hundred & ninety poles Crossing the Mouth of a Spring branch North thirty Degrees ease twenty seven poles to a black oak & Beech thence leaving the River South sixty nine Degrees east one hundred & Sixty six poles to two black Oaks by the side of the Barrens and on a hill by Green River thence along the Barrens South twenty Degrees West on hundred & fifteen poles to two hickories thence South twenty Degrees-- - - Whereof they have hereunto set their hand and seals the day and year first above written. /s/ Joseph Crockett /SEAL/ /s/ Elizabeth Crockett /SEAL/

INDEX TO A CENTURY OF WAYNE COUNTY, KENTUCKY 1800-1900. Compiled by Irene Byrer. Copyright 1974.

When the History of Wayne County, Kentucky 1800-1900 was written by Augusta Phillips Johnson, it did not contain a complete index. While the lack of an index does not detract from the information the book contains, it does seriously limit it's use for quick reference. Many times a book is scanned hurridly for a long-searched-for name which is not found, but was there and could have been located easily if the book had been indexed. Recognizing the need for a more complete index to the Wayne County History, Irene Byrer has compiled a 31 page index, using both given and surname.

Wayne County, Kentucky was formed in 1800 from parts of Pulaski County and Cumberland County, is located on the Kentucky-Tennessee border line, and is bounded by the Kentucky Counties, Clinton (1836); Russell (1825); Pulaski (1798); McCreary (1912);; and the Tennessee Counties, Pickett (1879); and Scott (1849).
