John WILLIAM FORD, D.D.S. of Mailliw mot

Excerpts of a biographical sketch of JOHN WILLIAM FORD, D.D.S. in TEMPLE BODLEY'S HISTORY OF KENTUCKY - -Volume 4, pp 399-401.

Dr. John William Ford, one of the pioneer dentists of Warren County, Kentucky, has practiced in Bowling Green for many years and through his inventive genius he has rendered a service of inestimable value to the profession. He was born December 6, 1846, in Barren County, Kentucky, and is a descendant of the old aristocratic Ford family of Virginia, who migrated to Kentucky and located near Glasgow Junction. His parents were Clement Ford and "Millie" (Emelia) Dickinson Ford, the latter also a native of Barren County, Kentucky, and a daughter of William Dickinson and "Kate" (Katherine) Hall Dickinson. Her father (William Dickinson) was born in Jew Jersey and became one of the prosperous agriculturists of Barren County, Kentucky, where he passed away. William Dickinson was an adherent of the Republican Party and a member of the Baptist Church. He was a representative of a famous old New Jersey family which was noted through several generations as a family of mechanical geniuses, inventors, jewelers, etc. Many of the farming implements and various mechanical devices or our day were invented by this family. Dr. Ford's maternal grandmother, Mrs. Kate (Hall) Dickinson was born in Hart County, Kentucky, and her demise occurred on the family homestead in Barren County, Kentucky. Dr. Ford's paternal grandfather, Professor John F. Ford came from Hanover County, Virginia, and he and his wife, Frances ____ Ford spent the latter portion of their lives in Barren County, Kentucky. Proffessor Ford was one of the pioneer educators of that district (i.e. Barren County, Ky.) and a Baptist in religious faith. His son, John F. Ford, Jr. (who married Catharine Harlow), was a Colonel in the Kentucky Militia, in which Clement Ford served as a Drum Major. latter, Clement Ford, worked at the carpenter's trade for some time, becoming a contractor and builder, but followed farming in later life. no voted the Democratic Ticket and was a member of the Baptist Church. His demise occurred in Johnson County, Texas, and his wife, Emelia Dickinson Ford, is buried there also.

Dr. Ford received his early instruction in the county schools of his native county, and for a time assisted his father, Clement Ford, in the contracting business. Later, he was connected with the jeweler's trade, first at Glasgow Junction, Kentucky, and subsequently at Auburn, Kentucky, following that occupation in all about ten years. He then studied dentistry and after passing the necessary examination opened an office in Bowling Green, Kentucky. . Dr. Ford is nationally known as the inventor of the partial artificial plate and gold clasp, which was at first regarded by dentists as impracticable, but time has demonstrated the worth of this device and it is now generally used by the profession.

John William Ford was married February 9, 1869, in Glasgow Junction, Kentucky, to Miss Margaret Kate ("Kit") Adams, a daughter of James and D. Jane (Dickinson) Adams and a native of Barren County, "Kit" Adams Ford was born May 28, 1847, and passed away June 9, 1910, in Bowling Green, Kentucky. Dr. Ford was married June 11, 1911, in Nashville, Tennessee, to Mrs. Eva (South) Webster, a daughter of Dr. John Fletcher and Mattie Belle (Moore) South. Mrs. Eva South Ford was born October 22, 1875, near Bowling Green, Kentucky, and in 1896 was graduated from Potter College of that place. chose the career of an educator and for some time was engaged in teaching in Bowling Green and in Warren County, Kentucky. She is an earnest member of the Seventh Day Adventist Church and the Women's Christian Temperance Union, and devotes much of her time to charitable work.

Dr. Ford is also, an Adventist, and a consistent follower of that faith. Dr. Ford was a Drummer boy in the Kentucky Militia and after the Civil War, joined the original order of the Ku Klux Klan. Dr. Ford rode on the first locomotive which made the run from Bowling Green Ky. to Louisville, Ky. on the Louisville and Nashville Railroad, and the engineer was Jack Mills, while William Car acted as fireman. Dr. Ford has wisely conserved his powers and is still an active factor in the world's work although he has reached the ripe age of eighty years (c1927). An ardent sportsman, he has been a member of many hunting and fishing expeditions and thoroughly enjoys life, making the most of it day by day. He has witnessed notable changes as pioneer conditions have been replaced by the improvements and advantages of modern times, and his reminiscences of the past are both interesting and instructive. Dr. Ford's career has been long and honorable, and his friends are legion. the latter portion of their lives in Barren County, Kentu

Dr. John W. Ford, 89 years old, who had been engaged in the practice of dentistry in Bowling Green since early life, died at noon today at his home at 415 1-2 Park Row following an illness of a week with pneumonia.

Funeral services will be held at 2 o'clock Sunday afternoon at the Seventh-Day Adventist Church, Park Street, of which he was a member, with burial following in Fairview Cemetery. The services will be in charge of Elder E. C. Banks, pastor of the local church.

Dr. Ford was born December 6, 1846, in Barren County, son of the late Clement and Millie Dickinson Ford. He was engaged in the jewelry business at Glasgow Junction and later at Auburn for about ten years before studying dentistry and moving to Bowling Green to practice.

He is survived by his second wife, Mrs. Eva South Webster, whom he married June 11, 1911, at Nashville, Tenn; and two sisters, Mrs.

Kate Mitchell of Rocky Hill, Kentucky, and Mrs. Betty Spears of Fort Worth, Texas.

During the Civil War he served as a drummer boy in the Kentucky Militia.

- 4. Immediately after the annual meeting of the members, the Board of Directors shall elect the President, not exceeding three (3) Vice-Presidents and the Secretary and a Treasurer and may further designate new and additional titles, offices and committees from time to time as it may deem proper.

NOTES FROM THE OLD MULKEY - SLAUGHTER BIBLE By Cecil E. Goode

The Bible from which these notes were taken is now in my possession. It came to me from my great grandmother, Sarah Elizabeth Mulkey Combs, through my grandmother, Sarah Amanda Combs Goode and my father, William Levie Goode. Originally it belonged to William Slaughter, Jr. who married Rebeccah Mulkey in 1805. Rebeccah Mulkey was a daughter of Jonathan Mulkey, one of the earliest Baptist preachers in what became eastern Tennessee. She was also a sister of John and Philip Mulkey, who figured in the early Mill Creek Church (now called Mulkey Meeting House) in southern Barren County (now Monroe County).

How the Bible came into my line I can only speculate. Rebeccah Mulkey Slaughter was the twin sister of my great great great grandfather, Isaac Mulkey, who was himself a pioneer Baptist preacher in eastern Tennessee. Rebeccah or her heirs may have given it to Isaac or his heirs which could explain why my line has it.

The Bible is in very poor condition and has notes scattered throughout it. Because I feared that it would completely disintegrate or become illegible, I made an extract of the notes that have genealogical value almost forty years ago (in 1940). The Bible remained in Washington County, Tennessee until the time of the Civil War, when it was brought to Monroe County, Kentucky by Sarah Elizabeth Mulkey Combs.

One interesting question raised by the Bible notes is the entry for Jonathan Mulkey's wife, Sarah. All Mulkey genealogists, to my knowledge, have listed Jonathan's first wife as Nancy Howard, daughter of Obediah Howard. Obadiah Howard had a daughter Sarah, but she is not recorded as Jonathan Mulkey's wife. It is possible that the Sarah listed was a second wife, but Rebeccah named her oldest daughter Sally Howard, which would suggest that Sarah's maiden name was Howard. Five of Jonathan's children named their first or second daughter Sarah, and only one used the name Nancy. I would welcome any information any readers may have that would shed light on this question.

Copied and contributed by Ray H. Garrison, 2625 Hawthorne Lane, Flossmoor, ILL 60422, from the Family Bible of Christopher Leamon Garrison (1844-1884), who was a son of John F. Garrison (b Nov 22, 1814 in that part of Warren Co., Ky., that later became Allen Co.; d Jan 22, 1885). Upon the death of Christopher Leamon Garrison, the ownership of the Bible passed to his daughter, Mary Estelle (Garrison) Heibner (1881-1971), of Holdrege, Nebraska, who made some of the later entries.

The complete title, name of publisher, and date of publication are as follows: The Holy Bible, containing the Old and New Testaments, translated out of the Tongues, and with the Former Translations Dilligently Compared and Revised; with the Concordance. (St Louis, Missouri: J. H. Chambers & Co., copyright 1872). The contributor, Ray H. Garrison (b. Allen Co., Ky., Aug. 6, 1922), has in his possession a photo of all the entries in this Bible.

Martha Ellen, and Haden Wylimaa onaria menico was born August

Haden Wilson Renfro and his wife, Rachel Ellen Preston Renfro came by covered wagon from Glasgow Junction, Barren County, Kentucky to make their home in Fannin County, Texas in 1890. Haden and Rachel are the great grandparents of Dr. Roy E. Renfro, Jr. of Grayson County. The ancestry of Haden Wilson Renfro is quite illustrious and will be presented from the beginning of the Renfro line.

The Renfro heritage in America spands over 300 years, as land grant records in Virginia before 1638 verify. Three brothers, James, Joseph, and William Rentfro were the forefathers of most of the present day Renfros in America. William Rentfro, of whom Haden was a descendant, was born in 1702 in James City County, Virginia and was married to Elizabeth China in 1726. Their son, William Renfro was born May 14, 1734, in Virginia and died September 1, 1830, in Culleoka, Maury County, Tennessee at the age of 96. His first wife's name is unknown, but to them were born six children: John, Lydia, Jane, Moses, Jesse, and Nancy. The William Renfro homeplace is still standing on the banks of Fountain Creek just east of Culleoka, Tennessee. The log home and its magnificent chimneys were built before Tennessee statehood and were previously in North Carolina. William Renfro is buried in the family cemetery on a tree covered ridge behind the Renfro home. William Renfro's first son, John Renfro was Haden's grandfather and he was born November 12, 1760 in Bedford County, Virginia, and died April 22, 1846 in Barren County, Kentucky. John Renfro married Esther Peak in February, 1781 in Henry County, Virginia. Esther Peak Renfro was born January 1, 1762 and died May 8, 1851 in Barren County, Kentucky. Both John Renfro and his father, William Renfro fought in the Revolutionary War having signed an Oath of Allegiance to the State of Virginia, Henry County Court House, 1777. John Renfro's pension records are in the National Archives in Washington, D. C. John served as a drummer boy and private in the Calvary in the Company commanded by Captain Hairston of the Regement commanded by Colonel Shelby in the Virginia Militia. John Renfro stated in his pension application that his father returned from the Battle of Yorktown and the surrender of General Cornwallis at about the same time that he returned from the John and Esther Renfro had six sons: Isaac, Jesse, John, William, Joshua, and Joseph. Haden's father was Joseph Renfro, who was born June 21, 1801 in South Carolina and died in October, 1853 in Warren County, Kentucky. Joseph married Sarah Ralston, April 28, 1821 in Barren County, Kentucky. Sarah Ralston Renfro was born March 22, 1806 and died March 20, 1852 in Barren County, Kentucky. Joseph and Sarah Renfro owned hundreds of scres of land along Skaggs Creek in Barren County and were farmers, lumbermill operators, wood craftsmen, and furniture makers. Joseph and Sarah Renfro had thirteen children: Beverly C., Robert R., Schuyler M., James Robert, John William, Thomas J., Isabel Susan, Catherine, Hardin Davis, Joseph R., Sarah E.,

Martha Ellen, and Haden Wilson. Haden Wilson Renfro was born August 22, 1849 in Barren County, Kentucky and died December 31, 1917 in Fannin County, Texas.

Haden married Rachel Ellen Preston November 30, 1876 in Glasgow Junction, Barren County, Kentucky at the Baptist Church. Rachel Ellen Preston Renfro was born January 7, 1852 in Barren County, Kentucky and died November 20, 1942 in Fannin County, Texas. Haden and Rachel came to Texas in 1890 with their seven children and lived ten years in Cottage Bend before buying land and moving to Lannius, where a home was built in 1900. Haden and Rachel reared their children in this home and were engaged in farming and ranching in Lannius the remainder of their lives.

The children of Haden and Rachel Renfro were: Elizabeth (1877-1944), James Robert (1880-1949), Kier David Preston (1882-1952), Ada (1886-1944), Eugene (1888-1911), Vernon Wilson (1890-1964), and Frederick L. (1896-1965). The Old Renfro home still stands tall and proud in Lannius where its current generation occupants are Mr. & Mrs. Roy E. Renfro, Sr. The old home has housed four generations of Texas Renfros. Haden Wilson and Rachel Ellen Renfro are buried in Dodd City Cemetery, Fannin County, Texas.

VERNON WILSON RENFRO

Vernon Wilson Renfro and his wife, Nona Wells Marchant Renfro spent their entire married life in the farming and ranching business in Lannius, Fannin County, Texas. Vern and Nona Renfro are the grand-parents of Dr. Roy E. Renfro, Jr. of Grayson County. Vernon Wilson Renfro was born July 24, 1890 in Fannin County, the son of Haden Wilson and Rachel Ellen Preston Renfro. Vern was born the year his parents arrived in Texas from Glasgow Junction, Barren County, Kentucky.

When Vern was ten years old (1900) the family moved from Cottage Bend which is three miles West of Bonham to Lannius which is ten miles East of Bonham. Vern had six brothers and sisters, including Elizabeth (1877-1944), James Robert (1880-1949), Kier David Preston (1882-1952), Ada (1886-1944), Eugene (1888-1911), and Frederick L. (1896-1965). Vern completed his education at Lannius in 1905 where his teacher was Mr. Sam Rayburn, who would later become Speaker of the United States House of Representatives. Upon his father's death December 31, 1917, Vern and his brothers took over the operation of the family farm which included 165 acres planted to cotton and corn along with beef production. All of the plowing and hay operations were done by horse power. Many of those early pieces of farm equipment remain on the Renfro property today, as a constant reminder of the pioneer spirit of those who used them.

Vernon Wilson Renfro died June 18, 1964. Nona Wells Marchant Renfro died November 1, 1951. Vern and Nona are buried in the Dodd City Cemetery, Fannin County, Texas.

Thomas Hardy was born ca 1748 in Luenburg Co., Va. The exact date he came to Barren Co., Ky., is not known - presumably between 1790 and His sons George and Isham were in Kentucky about this time - George settled where the Village of Seymour in Hart Co., is now, and Isham settled near the Blue Spring Grove 1795-1800, according to Cyrus Edwards' Stories Of Early Days. Thomas Hardy's will was submitted to the Barren County Court May 1812 and is on file in Will Book k, page 198. He was married to Mary Isham, daughter of Henry and Catherine Isham. Thomas Hardy's place of burial is not known.

The children of Thomas Hardy and Mary Isham are: Jeduthun; Rhoda who married Frederick Trump April 6, 1791; Thomas who married Mikeziah Powell June 25, 1790; Isham who married Mary Sneed August 14, 1792; Moses who married Sally Myers, December 7, 1796; Nancy who married Thomas Burks March 19, 1811; George who married Rachel Burks, January 9, 1814.

To the Honourable Judge of the Barren Circuit Court respectfully complaining sheweth unto your Honour Your Petitioners Susan F Preston, Widow of John B Preston deceased, Wm G Rodes and Eliza his wife late Eliza Jordan, Caroline M Jordan, Emily Ann Jordan, Samuel Jordan, John Jordan, James M Jordan and Hezekiah Jordan; the said Caroline M, Emily Ann, John, James M & Hezekiah being infants under the age of 21 years, sue by their Guardian & next friend James Murrell.

That many years ago Samuel Jordan, the Ancestor & Father of your petitioners, (except Wm G Rodes who since his death has intermarried with the said Eliza) departed this life intestate, seized of considerable real estate, consisting in part of certain Town lotts lying and being in the Town of Glasgow and known and designated in the plan of said Toen by their numbers, which are as follows: Towit - No 15, 45, 46, 47, 48, out lot N 4 & 8.

Petitioners would also represent that the Lotts at the time of the said Samuel's decease were unimproved, and still are, and have always been, and still are wholly unproductive to your Petitioners, of any profit, rent or emolument of any kind, and (unless sold) will still so continue as Petitioners can not improve the same profitably or even without final loss. Said lotts are situated that they are not of any use to any person except the proprietors of the adjascent property, who are desirous of purchasing at a fair price, provided a sale of the interest of your Infant Petitioners shall be authorized by Court.

Your Petitioners state, and the said Murrell concurs in the statement, that a sale of said Lotts of ground would redound much to the advantage and interest of your Petitioners, and particularly to the advantage of the infant petitioners.

They would further state that the said Samuel Jordan deceased, at his death left one other child & heir at law, towit, Mary Jordan, who afterwards intermarried with Granville Rodes, and has since departed this life without ever having any issue.

In consideration of all which, and as Petitioners have no remedy at common law, they pray that your Honour will decree a sale of the lotts afs'd in manner and form prescribed by law, or at least of the interest of your Infants Petitioners in said Lotts, for they all alledge that unless the entire title can be passed, including the interest of both adults & infants, the adults can not make sale of their interest. May it please the Court to grant all such relief as the law requires or as the parties are intitled to.

Page 115 - 116 - Col. Samuel Murrell was born Alebmarle County, Va. and was one of the pioneers to this county at an early day. He married in Virginia, Miss Puryear, and when he came to this state he brought a large family of children, William, George, Samuel, Hezekiah P, Betsey, James, Schuyler, Jane and Robert. His daughter Polly who had married Samuel Jordan in Virginia, came with them. Col. Murrell was twice elected to the Legislature of this state 1809-10 - declined a re-election, politics not being suitable to his quiet and domestic habits. Was for many years an Elder of the Presbyterian Church

Samuel Jordan and wife Polly were two excellent persons. He was a bricklayer, a good and faithful workman, and built several of our brick houses. They lived in town many years. He afterwards purchased Col. Simeon Buford's farm on the west side of Beaver Creek, built on it a substantial brick house, and with his family lived there until his death. He also built the brick mill house on Beaver Creek below the bridge that crosses the Denton-Bowling Green road and owned the same at his death. He was trustworthy, amiable, temperate, charitable, bland in his manners - in fact, his character was irreproachable in all things. He and his wife were worthy members of the Presbyterian Church. She survived him many years.
