- Academic Council Tim Leigh announced Academic Council will meet March 31 at 3:10.
- Rules & Elections Mike Pearson made a motion to restrict ASG candidates to a one-to-one basis during the campaign period in any public area on campus (seconded by James Brown) Passed 18/13
- Interhall Council will hold a meeting April 7 at 4:00 in room 439 Downing. All ASG candidates are invited to speak.
- Old Business Bill No. 7 (Amendment to the By-Laws) was brought on the floor by Kevin Kinnie and seconded by Charles Hardin. Charles Hardin made a motion to insert an amendment saying that the first roll call vote of a resolution, bill, or amendment to the by-laws would be considered as roll call for attendance (seconded by Kevin Kinnie) Failed 17/15/1
Bill No. 9: Gene Saunders made a motion to eliminate points 1-4 and accept this bill (seconded by Colleen O'Neil) Passed 14/12/4
Division of the House was called, Passed 16/13/3
- Revised Constitution: John Evans made a motion to rescind the vote on Article II Section 4. Because of a lack of 2/3's membership in congress this was dropped.
Theresa Jenkins made a motion to insert a No. 6 of Article II stating that all executive officers shall have completed or be in the process of completing one hour of parliamentary procedure seconded by John Evans/Failed by Majority. The Constitution will be back on the floor April 5.
Tim Leigh made a motion to have the revised by-laws be in a handbill form (seconded by Kirt Grubbs) Passed by Majority
- New Business Bill No. 10 had its first reading
Resolution No. 24 was withdrawn
SGAK: Charles Hardin made a motion to invest authority in the two delegates to SGAK to ratify the SGAK Constitution (seconded by John Evans) Passed 14/6/2
The two alternates to SGAK are Betsy Hirst and David Payne.

After the passage of Bill No. 9 it was moved by Kevin Kinnie and seconded by Charles Hardin to accept the bill on Public Higher Education authored by Eastern Kentucky University to go along with Bill No. 9. This was passed by majority. It was recommended to include in this a raise on financial assistance for KHEAA. Passed by majority
