## Archaic Terms Used for Causes of Death

*Judy Davenport recently gave a presentation to the monthly Society meeting on health related issue affecting our ancestors. She discussed some of the most frequent causes of death for our ancestors. The editor felt that other members might benefit from a list of some of the more common terms. The following list defines some of the terms frequently found in mortality schedules.*

**Ague**-Any intermittent fever characterized by periods of chills, fevers, and sweats. Usually associated with malaria.

**Apoplexy**-Paralysis due to stroke.

**Bad Blood**-Syphilis.

**Bilious Fever**-Loosely applied to intestinal fevers and malarial fevers. Sometimes applied to typhoid, malaria, hepatitis, or elevated temperature and vomiting.

**Blood poisoning**-Bacterial infection.

**Brain Fever**- Meningitis caused by bacteria; often fatal; encephalitis.

**Catarrh**-Inflammation of mucous membrane, especially the air passages of the head and throat with a discharge. Characterized by cough, thirst, fever, increased mucus secretion of air passages; a cold.

**Child Bed Fever**-Infection in the mother following birth of a child, probably due to staphylococcus.

**Cholera**-An acute, infectious disease characterized by profuse diarrhea, vomiting, and cramps. Spread by feces contaminated water and food.

**Cholera Infantum**-A common, non-contagious diarrhea of young children, occurring in summer or autumn. Death frequently occurred in 3-5 days.

**Congestive chills**-Malaria with diarrhea.

**Congestive fever**-Malaria.

**Consumption**-Tuberculosis; infectious disease caused by bacteria *Mycobacterium tuberculosis*; also called phthisis.

**Croup**-a group of diseases involving inflammation of the upper airway leading to a characteristic barking cough. Most commonly involves parainfluenza virus. Most children with croup are between 3 months and 5 years. In severe cases, the upper airway becomes swollen to the point that it is partially blocked.

**Dropsy**-Not a specific disease but an accumulation of fluid; may be due to obstruction of a vein; most commonly due to heart or kidney failure.

**Dysentery**-Disease involving the inflammation of the lining of the large intestines causing stomach pain and diarrhea; may involve vomiting and fever. Usually caused by bacteria entering the body through the mouth in food or water or by contact with infected people. Death is generally due to dehydration.

**Enteric Fever**-Typhoid Fever.

**Enteritis**-Inflammation of the bowels.

**Erysipelas**-A skin infection typically caused by group A beta-hemolytic streptococci. Involves the skin and lymphatics. Characterized by intense reddening, hardened masses, sharply defined borders. Generally benign but can be fatal when associated with presence of bacteria in blood stream.

**Intermittent Fever**-Malaria.

Mortification-Gangrene.	inflammations of the skin, mucous membrane, bones, joints, and other parts.
Nephritis-Inflammation of kidneys.	
Pertussis-Whooping Cough.	Spotted Fever-Probably typhoid.
Peurperal exhaustion-Death due to child birth.	Summer Complaint-Diarrhea occurring in summer, especially when produced by heat and indigestion.
Pleurisy-Inflammation of the membranous sac lining the chest cavity. Symptoms are chills, fever, dry cough, pain in side.	Teething-The entire process which results in the eruption of the teeth. Death by teething was probably due to either infection due to lancing of the gums or due to drinking contaminated milk due to weaning at the time of teething.
Pox-Syphilis.	
Rheumatism-Any disorder associated with pain in joints.	Typhoid Fever-Caused by bacteria; carried in bloodstream and intestinal tract; causes sustained high fever, stomach pain, headache, loss of appetite, rash; usually contracted through food or drink.
Scirrhus-Cancerous tumors.	
Scrofula-Form of tuberculosis characterized by swelling of the lymphatic glands; marked by tendency to develop chronic intractable	Yellow Jaundice-Generally liver disease.

## Medicine in Early America

The causes of few diseases were known. The great specific of the day was mercury, but opium was freely administered, and Peruvian bark. The great majority of the doctors believed that blood-letting was the most effective treatment for most diseases. They believed that it lessened morbid and excessive action in the blood-vessels and removed fever, that it lessened pain, induced sleep, prevented hemorrhages, and was a safeguard against relapses. The bleeding was generally performed by a barber because he was a specialist in this branch of surgery.

Usually bleeding was done by opening a vein in the arm, neck, or foot. Leeches and the cup were sometimes used. Before a patient was bled, he was given an emetic and a purge. Mercury was given to produce excitement and inflammation of the glands of the mouth and throat and abstract excitement and inflammation from the more vital parts. This was especially desirable if there was morbid congestion and excitement of the brain. Besides this, the patient was usually blistered.

Bleeding was believed to completely deplete the patient so that there would be nothing for the disease to work on. The patient's chances of recovery were thought to be improved. Bleeding was common through about 1850.

## Salem Meeting House, 1820 Warren County, Kentucky

Since I first saw the listing of the "Salem Meeting House" in Warren County court records several years ago, it has been my wish to collect some facts about this long-forgotten church or school. Few facts indeed have been found to date, but I do present what has been found and hope that additional facts can be uncovered in the future.

The exact location of the Salem Meeting House has not been determined. From a close study of a Warren County deed and court order book, it is evident that this building was in north central Warren County near Little Beaverdam Creek placing it at or near the present Edmonson County border. No doubt its present location would be in the Sandhill or perhaps the Penns Chapel community of extreme north central Warren County.

Efforts to pinpoint the exact faith of this church have also been fruitless. Nothing has been found to link this body to the Baptist faith. Research into local Church of Christ and Methodist records did not reveal a church by such a name during the general time period. However, it has been proven from Warren County Order Book E that there was a building called the "Salem Meeting Houses" as early as 1820. The other known listing of the old meeting house in local court records was in 1834 in Warren County Deed Book 15. At least we know that it was a known building or landmark by 1820 and that it was still standing at least as late as 1834.

To shed some light as to the general location of the old meeting house, we will look at the reference to it in the Warren County Order Book E. At the February 7, 1820 court the following entry was made:

"The persons appointed to view the nearest and best way for a road to be opened from **Thomas Sterrett's** to **Honaker's** Ferry made their report. . . Ordered that **John Young** be surveyor of the road from the top of the knob near **Benjamin Miller's** to Honakers Ferry and all the hands within the following bound to wit: Beginning at **Nicholas Shrader's** [Schroader] including him thence to and including **Peter Jones** thence to Salem Meeting house thence to **Thomas Earnest's** on Green River thence down the river to Indian Creek thence up the creek to **James Young's** Mill thence a straight line to the top of the knob near **Ben Millers** to assist said **John Young** in keeping said road in repair."

Clearly, the road to be opened follows the current Highway 185 from Bowling Green north to Green River. **Thomas Sterrett's** fine old brick house is still standing on the side of Highway 185 at the point where Rays Branch crosses the highway. The knob near **Benjamin Millers** must be the hill just above Rays Branch and the old Sterrett home [near the junction of Highways 185 and 263]. From that point, the direction of the boundary line listed is an eastwardly direction towards the Sandhill or Penns Chapel area and into present day Edmonson County to Green River. In 1820 Edmonson County had not yet been created and **Thomas Earnest** on Green River would now be in Edmonson County on the south of the river.

The next reference to the Salem Meeting House is found in Warren County Deed Book 15, pages 411-412. On July 29, 1834 the sheriff of



Warren County, **Chasteen Dunavan** sold at auction to **J. R. Underwood** one tenth part of 900 acres of land and of 196 acres on Little Beaverdam Creek. Those two tracts had been patented to **Samuel Goode** and **Thomas B. Monroe** in 1818. The execution by the Warren County sheriff was in favor of **William Smith** against the estate of **John C. Goode** by order of the Edmonson County Circuit Court. **John C. Goode** was one of the heirs of **Samuel Goode**.

The deed refers to the boundary of the 900 acre tract as "beginning at **Elijah M. Covington's** corner near Little Beaverdam and near the road leading from Salem Meeting house to **Cowles** and **Watts** running with said Covington's line.....to a line run for **Henry Jones** and about 40 or 50 yards from Salem Meeting house. . . ". The deed describes the boundary of the 196 acres tract as follows "Beginning at two post oaks standing to the left hand of the road leading from **Peter Jones's** to **John C. Goode** and about 600 or 700 yards from where said Jones now lives . . . to a 100 acre survey made in the name of Samuel Good. . ."

Two facts in the 1834 deed may possibly shed some light as to the religious order of the Salem Meeting house. First, the **Henry Jones** boundary line was only "40 or 50 yards" from the Salem Meeting house. **Henry Jones** had been given permission by the Warren County

Court in 1799 to perform marriages so he must have been a minister of the gospel. Was he the minister of the old Salem congregation? Henry's land was on Ivy Creek and the waters of Green River. He did marry many couples after 1799 according to the marriage bonds of Warren County. Secondly, the land of **Peter Jones** joined that of **John C. Goode**. In 1804 Peter was the security on the minister's bond of one **Durham Turner** (of the Methodist Church) so that he could also perform the marriage ceremony in Warren County.

Mr. **Richard Weiss**, Archivist of Kentucky Wesleyan College of Owensboro, Kentucky, was unable to find a listing of Salem Church or Salem Meetinghouse in Warren County of that era. A listing of Churches of Christ in Warren County for 1848 failed to name a Salem church. Mr. **Norman Warnell**, historian, author and active in the Baptist Churches of Edmonson County failed to find a Salem as being a Baptist church of that area.

No firm answers have been revealed by these court records. However, I do present these facts to stimulate interest in learning more about this old meeting house. It is my hope that in the future more information on the church can be found.

### James C. Corley Obituary, 1908, Muhlenberg County, Kentucky

From *The Record*, Greenville, Kentucky, 13  
August 1908.

Mr. James C. Corley, An Honored and Highly  
Respected Citizen Passes Away at His Home  
Near Earles Last Sunday Night.

Mr. James C. Corley, aged 64 years, died of  
cancer of the stomach at his home near Earles  
at 9 o'clock Sunday night, after an illness of  
some months. There were few more progressive  
men in the county than Mr. Corley, and he was  
a leader in his section. Deceased was a member  
of the Baptist church, and an exemplary citizen  
in every respect. He is survived by six children,  
three boys and three girls, and his father, Mr.  
**Granville Corley**, who is now in his 87 year.  
The body was carried Monday afternoon to the  
family graveyard, near the Randolph place, a  
few miles distant, and the service conducted by  
**Rev. W. H. Woodson** in the presence of  
several hundred people. The burial was  
conducted by the Masonic fraternity, with full  
rites. The place occupied by Mr. Corley will be  
hard to fill, and his death has caused general  
sorrow in many homes.

### Edgar Armstrong Obituary, 1951, Rosewood, Kentucky

From *The Times Argus*, Central City,  
Kentucky 26 July 1951.

Rosewood-**Edgar Armstrong**, 57, retired  
farmer and former county court clerk of  
Muhlenberg County, died at his home in  
Rosewood Sunday, at 12:14 p.m. He was  
prominent in Muhlenberg County Republican  
politics for many years.

He was elected county clerk in 1932 and served  
four years.

Funeral services were held on Tuesday at 2:30  
p. m. at the Macedonia Baptist Church in  
Rosewood by the pastor, the **Rev. David  
Mefford**. Burial was in the Chaplin Cemetery  
in Bloomfield.

He is survived by his wife, Mrs. **LaRue  
Armstrong**, Rosewood; three daughters, Mrs.  
**Wilton Thomas**, Bloomfield, Mrs. **Lindle Earl  
Motes**, Royal Oak, Michigan, Miss **Erdine  
Armstrong**, Rosewood; three sons, **Edgar  
Muir Armstrong**, Homestead, Pennsylvania,  
**H. W. Armstrong**, Royal Oak, Michigan,  
**Sherman Armstrong**, Detroit; four sisters,

### **Judge S. W. Brents Obituary, 1890, Glasgow, Kentucky**

From "Life in This Community Over Half Century Ago", *The Glasgow Times*, 6 August 1942, Glasgow, Kentucky. Taken from *The Glasgow Times*, 9 July 1890.

Judge **S. W. Brents**, 72, died Saturday morning. He was born in Greensburg in 1818. He was a former Legislator of Barren County and also City Judge. He was buried Sunday and is survived by three children, Mrs. **William Dickinson**, Mrs. **Morgan Brents** and Mrs. **Ed N. Caldwell**.

### **James E. Wallace Obituary, 1856, Dunmor, Kentucky**

From *The Time Argus*, 20 Dec 1956, Central City, Kentucky.

Dunmor - **James Emmett Wallace**, 78, died at his home in Dunmor Saturday, Dec. 15 at 11:45 p.m. Funeral services were conducted Monday, Dec. 17 at 12:30 p. m. in Drakesboro with the Rev. **John Steele** officiating. Burial was in Hughes Cemetery.

Survivors are wife, Mrs. **Annie B. Wallace**; two sons, **William Clayborn Wallace** and **Floyd Wallace** of Penrod Route 1; three daughters, Mrs. **Rosie Abbott** of Nortonsville, Mrs. **Jessie Williams** of Penrod Route 1, Mrs. **Lucy Shelton** of Drakesboro; 19 grandchildren, six great-grandchildren.

### **William Thomas Welborn Obituary, 1931, Russellville, Kentucky**

From *The News-Democrat*, 18 Jun 1931, Russellville, Kentucky.  
Union Veteran Passes to Rest

### **W. T. Welborn, Aged Local Resident, Dies Following Paralytic Stroke**

Illness of ten days following a paralytic stroke caused the death of **W. T. Welborn**, of East Fourth Street last Sunday. Funeral services conducted by Rev. **C. B. Jackson**, were held Monday and interment followed at Dunmor, near the place of his birth, and where he spent the greater part of his life.

Mr. Welborn was past eighty years of age and was reared near Dunmor, residing there until about twelve years ago, when he moved to this city to make his home. He was the father of ten children, a number of whom survive. He is also survived by his wife and a number of other near relatives in the city and county. The deceased was a Union soldier in the War Between the States.

A large number attended the services here, and also the burial, and gave expression to the fact that the deceased was beloved and will be missed, by many who had known him so long and who will sympathized with the bereaved relatives.

### **Leslie Bodine Obituary, 1909, Russellville, Kentucky.**

From the *Todd County Times*, 23 July 1909, Elkton, Kentucky.

School Teacher Drowned  
Russellville, Kentucky.

July 16. **Leslie Bodine**, son of **J. W. Bodine**, of the north end of Logan County and a promising young school teacher was drowned in a deep pond in a rock quarry two miles north of this place this morning. His body was recovered.

Bodine was scheduled to read a paper today before the Logan County Teachers Institute and went out to the quarry with a pencil and pad to prepare it. Finishing the paper he started to take a bath. The pond is fed by a cold spring in the bottom and the young man became

suddenly chilled and was seized with cramps. His cries were heard but he could not be rescued.

### **James M. Brown Obituary, 1886, Morgantown, Kentucky**

From the *Green River Republican*,  
Morgantown, Kentucky.

**James M. Brown** passed away in peace 20 May 1886 at the residence of his daughter, **Mariah Mayhugh** while his grand and great-grandchildren were playing in the yard. He was in his 87<sup>th</sup> year, was born and raised within one mile of Townsville and has lived in two miles of same all his life. He was one of the most quiet peaceable citizens I have ever seen. He was a member of the Bethel Baptist Church and was anxious to be called away 20 years ago. Peace to my sainted uncle till we meet in the Resurrection. **R. G. Brown.**

### **James C. McCormick Obituary, 1842, Warren County, Kentucky**

From the *Banner and Advocate*, 3 March 1843, Lebanon, Tennessee.

**William J. Morton**, a Baptist minister, and once Judge of the Logan County Court, and a brother of **M. B. Morton, Sr.**, now deceased.

## **Commencement at the Glasgow Normal School, 1890.**

Commencement exercises at the Glasgow Normal were described, having taken place at Normal Hall the previous Thursday evening, "The ladies wore Memphis gowns designed by Mrs. Jenness Miller of white mull. The men were gracefully attired in white flannel shirts, black pants and white sashes. The stage was artistically draped in green and white cheesecloth with rustic fence of grapevines across the front." This was described as the most elegant commencement ever held in the sixteen years of the normal's existence.

## Book Review

Lynn E. Niedermeier, *That Mighty Band of Maidens, A History of Potter College for Young Ladies Bowling Green, Kentucky, 1889-1909* Bowling Green, Kentucky: Landmark Association, 2001.

The Pleasant J. Potter College, founded in 1889 in Bowling Green, Kentucky, was not just another women's college carrying on the traditions of the southern female academies of the time. Gains in higher education for women had recently been made, opening the way for two decades of change in the role of women in American culture. Potter College educated this new breed of young women who balanced their cultural inheritance with their role in a changing society.

Ms. Niedermeier used a variety of original documents to provide the first comprehensive

history of Potter College. Her work is extremely well documented. The historian will find her documentation thorough and her organization of the material well planned. The writing style makes the book extremely easy to read and very entertaining.

The book includes a number of early photographs as well as a comprehensive index. Appropriate quotes from the period help to set the tone for each chapter and help the reader understand the climate of the time. Footnotes contain both documentation and commentary.

The book won a well-deserved award of merit from the Historical Confederation of Kentucky. It would make an excellent gift for anyone who is interested in the history of Bowling Green, the history of Western Kentucky University, or the history of women's education in Kentucky.

I **Geo E. Draughon** of Robertson County Tennessee make this my last will hereby making void all wills heretofore made by me I give devise and bequeath my estate and property real and personal as follows, that is to say

Item 1<sup>st</sup> It is my will and desire that my funeral expenses and all of the just and legal debts that I may owe at the time of my death be paid out of the first money that come into the hands of my Executors.

Item 2<sup>nd</sup> I give and bequeath to my beloved wife **Tabitha M Draughon** all of my house hold and Kitchen furniture Carriage Buggy and harness of each Also my buggy horse

Item 3<sup>rd</sup> I give grant and will to my wife **Tabitha M Draughon** the farm on which I now live and at her death to be sold by my Executors and the proceeds to be divided equally among my children as hereinafter devised - this farm can be sold at any time after my death my wife giving her consent. It is also my will that my Executors pay to my wife **Tabitha M Draughon** (\$50000) five hundred

I have made no advancement either in money or otherwise to my daughter **Tabitha M Draughon** and in consideration and to make her equal with my other children in amount that I have advanced them It is my will and desire she have my town property House and lot known as the **Judd** property. she will be charged with only \$2000 two thousand dollars for this property as she has been very kind and affectionate myself and wife waiting us for long years.
