The Board of Regents met in the office of President Cherry on October 14, 1926. All members of the Board were present including Superintendent Rhoads, Mrs. James, Mr. Cuthbertson, Col. Stites and General Denhardt. President Cherry was also in attendance.

The reading of the minutes for the previous meeting was dispensed with until a later time.

President Cherry made a statement before the Board of matters of equipment that would be needed in the new Home Economics building. He was authorized in conjunction with Miss Day and others whom she might name, to prepare a list to be submitted for bids subject to the action of the Board of Regents. It was understood that the Manual Training Department should make such of the equipment as they may be able to make to advantage. This was moved by Regent Cuthbertson, seconded by Mrs. James, passed unanimously.

Upon motion of General Denhardt with a second from Col. Stites it was agreed that a similar estimate for equipment for the Music Hall should be prepared and submitted so that the bids received may be submitted to the Board of Regents at the same time that the bids for the Home Economics Department are submitted. Motion was made by Mrs. James that a committee composed of General Denhardt and Mr. Cuthbertson be authorized to sell the Frisbie Hall and Bailey Hall property at or as much as possible in excess of \$14,325, the price offered at auction, as they may be able and that they be authorized and empowered to sign, make and acknowledge deeds to the purchaser or purchasers for and on behalf of the Western Kentucky State Normal School and Teachers College. The motion was given a second by Col. Stites, each member voting in the affirmative.

Upon request of Mrs. James information concerning the deposits in the two Bowling Green Banks was given. It was explained that the policy of the Board heretofore has been to distribute the funds equally and the Board reaffirmed their desire that there should be an equal distribution between the two banks. The motion was made by Mrs. James and given a second by Gen. Denhardt and passed unanimously.
