City of Bowling Green.

THIS delightful city is situated on the Louisville and Great Southern Railway, 113 miles from Louisville, and 72 miles from Nashville, and is justly styled the metropolis of the Green River country. It is located in a rich and fertile valley, at the head of slack water navigation on the banks of Big Barren river, which is a tributary to Green river. It is one of the most lovely cities in the South; possessing a population of about six thousand inhabitants. It is supplied with magnificent water works which furnishes the city with an abundance of pure water, which doubtless contributes greatly to the health of the inhabitants. In addition to this the city is lighted by beautiful gas light. Her streets, which are broad and well Macadamized, are kept remarkably clean, while her pavements are unusually broad and well laid with brick.

Bowling Green possesses a magnificent court house, quite a number of beautiful churches, three female schools, one male college, besides other useful auxiliary institutions of learning. In the midst of the city is situated "Fountain Park," with its playing fountain, gravel walks, forest shade trees, and its statuary, all neatly encircled by a tasteful iron fence, making a gem worthy of the admiration of the most fastidious connoisseur.

Bowling Green possesses quite a number of flourishing dry goods stores, which are conducted by experienced and tasteful merchants, who do quite an extensive business in their line.

It has four drug stores, three silver-smith establishments, two marble-cutting and tomb-stone establishments, five hotels, one iron foundry, and three livery stables. It has one pork-house, which has been in operation for many years, having been established on account of the facilities for transportation by boats prior to the building of the Louisville and Nashville railroad, though it still does a flourishing business. It contains two newspaper offices, and one job-printing establishment; three banks, and a neat and commodious theatrical hall. It is well supplied with reliable practitioners in the legal and medical fields, while her pulpits are filled by men who would compare favorably with those occupying pulpits in larger cities.

While it has the natural facilities to be a grand manufacturing center—possessing fine water-power, as well as cheap food and fuel—it as yet has not been developed in this direction. The leading manufactories are a woolen-goods manufactory and an ax-handle factory—both in quite successful operation; though the latter has been established within the last three years.

This part of the State was originally settled, in large part, by emigrants from the "Old Dominion," consequently her citizens possess more hospitality, courage, gallantry and intelligence than is often found in cities of similar numbers and wealth.

Taking the beautiful site on which it is built, the advantages for travel and transportation which it possesses, combined with the taste, thrift and intelligence of its people and it is difficult to find throughout the Sunny South a city more lovely and attractive than Bowling Green.

The City of Russellville.

RUSSELLVILLE, the county seat of Logan county, is beautifully situated on the Memphis Branch of the Louisville & Nashville Railroad. It contains a population of about 3,000 souls, and is a progressive, enterprising little city. The country around Russellville is very fertile and consequently furnishes abundance of her productions to other places, in addition to what is consumed in her own immediate vicinity.

All that is required for a rapid growth of Russellville is a little more energy on the part of her people. They, it is true, manifest no small amount of energy and enterprise, but they could, by a little greater effort, achieve much more; and as the yield of her productions last year (1875) were so bountiful, we feel sure it will have a tendency to make them in the future labor more dilligently. Russellville contains one very lively Democratic newspaper, which is edited with much ability.

Should sufficient inducement be offered to the right kind of manufacturers, we see every reason for a large increase in the size and prosperity of Russellville. The business men of Russellville and her citizens generally are very energetic and intelligent. The present standing of the city, commercially, and the status of her citizens socially, are just sources of pride and we predict for her a future of growth and prosperity. The Hotels of Russellville are the Forst House and Gray's Hotel, both first-class Houses.

Bethel College.

Bethel College is located in the town of Russellville, Logan county, Ky., on the railroad from Louisville to Memphis, 143 miles from Louisville, near the State line.

It was originated by the Bethel Baptist Association of Southwestern Kentucky in September, 1849. The present commodious building was afterward erected, and Bethel High School was formally opened January 3d, 1854. Under the management of Mr. B. T. Blewett, as Principal, the school prospered greatly, so that in accordance with the evident public demand for collegiate instruction a new charter was obtained, and the Institution entered upon a career as a College in the fall of 1856.

President Blewett continued in charge of the Institution, with great success and flattering prospects, until the summer of 1861, when the distractions of the war made it necessary to suspend operations. In the winter of 1861-62, the buildings were used as a hospital by the Confederate forces lying at Bowling Green, until the fall of Fort Donaldson in February. In September, 1863, collegiate exercises were resumed under Rev. Geo. Hunt, as President, who succeeded, amid many discouragements, in re-organizing the Institution, and giving it a new impetus. On the resignation of President Hunt, in September, 1864, Professor J. W. Rust was elected President. Under his direction the Institution continued to grow in numbers and influence, until he was compelled by impaired health to resign, February 1st, 1868.

On the resignation of President Rust, Noah K. Davis was

elected President. In 1873 President Davis resigned, to take the chair of Moral Philosophy in the University of Virginia, and the discipline of the College was committed to Leslie Waggener, as Chairman of the Faculty.

Since its revival after the war, the movement of the College has been continuously upward. The Trustees and Faculty have toiled incessantly and successfully to maintain a high standard of scholarship, and to contribute to society men of sound and thorough training. The present enlargement of its means and prospects is one gratifying result of the efforts.

From its origin until now there has been a class of young men in Bethel College studying for the gospel ministry. Its numbers have varied from twenty to thirty in a Session. The proper training of this class has ever been, and will continue to be, one chief object of the College. They are encouraged to pursue the full classical course, and special instruction relating to their calling has been given to them for many years. By the establishment of the school of Theology the advantages enjoyed by this class of students are now greater than heretofore, and will meet the wants of the large number who need elementary instruction, and have not time or means to pursue a more extended course.

The funds of the College have been carefully managed, and have steadily increased. In 1860 the Endowment, in Stocks, Bonds, etc., was reported by the Treasurer as more than \$40,000. In 1865 it was reported as more than \$50,000; in 1867, \$55,000; in 1869, \$63,000. At the present date, 1876, it is \$85,000. It has also a Beneficiary fund of about \$8,000. In addition to these funds, the College owns real estate valued at \$85,000, besides the College buildings and grounds. The Institution has no debt, and has at no time expended more than its income.

Glasgow is an inviting field for industry and capital and there is abundance of room for the judicious exercise of honest blows.



The City of Franklin.

FRANKLIN, Kentucky, county seat of Simpson county, is situated on the Louisville & Nashville railroad, 133 miles south of Louisville and 58 miles north of Nashville. It is a thriving and enterprising city of 3,000 inhabitants. During the late war the business of Franklin was destroyed, as it was with other cities similarly situated. The place itself underwent the vicissitudes of passing from the power of the Confederates into that of the Federals, suffering calamities at almost every change. Buildings were burned, property destroyed or removed, prominent citizens driven off by the uncertainties and disasters of those troublesome times, and the entire order of civil and social life transformed, after which Franklin very naturally presented hardly a vestige of her former self. The few business houses that remained were closed and empty. The inhabitants were without means, and to a great extent without hope.

Spring came apace; the fertile soil once more turned beneath the plow. The sound of the sturdy blows was heard in the work-shop. Town property, which a short time before was almost worthless, rose in value; a spirit of enterprise pervaded the population and all things seemed to bespeak for her a future of prosperity. Franklin is to-day, taking everything into a proper consideration, in a very prosperous condition.

She contains a live newspaper, four churches, three drug stores, three saddle, bridle and harness manufactories and a great number of miscellaneous business houses and one of the best hotels in the country. The hotel referred to is the Boisseau House conducted by Mr. Bryan.

Should sufficient energy be put to bear we see every reason for a large increase of business in Hopkinsville and a future of prosperity. She contains two lively newspapers, four or five churches, three hotels and many other good business houses, but time and space forbids mentioning all.

The City of Clarksville.

QUING to the extensive popularity of this city we feel that we can say but little (if any) to introduce it to the world; having such an extensive trade in all the various departments of business, especially tobacco, it is well-known, not only throughout the United States, but is known to the world. No place of the same size possesses the name that Clarksville does. The tobacco bought and sold there annually is more than double that of any other market in the country, in consequence of her superior facilities for preparing it for foreign markets.

Clarksville is indeed a place in which there is a vast amount of business transacted. She is a beautiful place, and pleasantly situated, in the best country in the State of Tennessee. Environing Clarksville are hills of lovely beauty whose round crests and sloping sides portray a lovely sight. A more desirable place to reside can scarcely be imagined. A place for the palatial residence of the wealthy, the ordinary residence of the middle class and the humble cottage of the poor. Here too are schools that compare favorably with those of larger cities.

In Clarksville can be found all kinds of employment for the mechanic and laboring man. The many tobacco warehouses furnish employment for quite a number of laborers, which is an advantage very seldom extended to so many laborers in a place of the same population.

Clarksville contains two live newspapers, one the Clarksville Tobacco Leaf, published by H. M. Doak; the other the Clarksville Chronicle, published by Messrs. Neblett & Grant; both

live, interesting sheets, edited with ability and care. We would like to mention many other firms, but have only mentioned a few and refer the reader to our advertising columns for the remainder.

There is perhaps no other point in the Mississippi Valley on which the friends of education can be induced to concentrate their energies and their patronage with more entire satisfaction to all parties, in view of all the requisites of a proper location for an institution of a high order and large patronage.

HEALTH.

The health record of Clarksville is remarkable. This city has uniformly escaped the ravages of cholera and other epidemics which sometimes rage with such violence in some parts of the Mississippi Valley. Billious fevers have been very rare for many years and typhoid fever is almost unknown. Cistern water is used exclusively, and the construction and management of cisterns has been brought to great perfection. Students from the malarious districts improve with great rapidity. No student has ever died here, and since the re-opening, five years ago, there has not been a case of severe sickness among the students.

SOCIAL FEATURES.

The students are cordially received into the best society in the city, instead of being thrown off as a separate community, and they soon feel at home in the church and in the family. In social style our people are substantial and conservative, rather than frivolous and extravagant. 


