\*\*\* MINUTES OF JANUARY MEETING \*\*\*

The regular meeting of the Kentucky Colonel Chapter was held on January 25, 1983, at the Briarpatch Restaurant. The meeting was called to order at 6:40 p.m. by President Michele Neal. The invocation was given by Mary Hines who also led the Pedge of Allegiance. There were 20 members and two guests present. The guests were: Cindy Kessinger and Lyndia Cherry.

Pat Cole, program co-chairman, presented an orientation session to the chapter. She began by reviewing the chapter on the history and origin of the American Business Comen's Association. Using the procedures manual as a guideline, she explained the national structure and levels of the association. In order to review the local level, each officer described her duties and responsibilities of her office. The standing committee chairmen explained what each specific committee does throughout a fiscal year. Pat Cole told of the different special committees and what they do. The several ways and means projects were also explained in detail.

One of our newest members, Angie Yokley, was introduced by Pat Cole as the vocational speaker for the meeting. She is employed in the central files department at American National Bank where she has been employed for four years. She works in a five-girl office whose duties are to keep on permanent record over 42,050 files. She makes internal references, and all other general office duties. Angie is also attending college working on her associate degree in banking.

The minutes from the November and December meetings were submitted in the January issue of the bulletin. After review a motion was made by Karen Towell, and seconded by Peggy Sharer, that the minutes from both November and December be accepted as submitted. Motion carried.

The treasurer's report was submitted in the bulletin. The balance in the checking account was \$573.24 and the balance in the savings account was \$1,031.73. The treasurer's report was accepted as submitted.

President Michele Neal read correspondence from national as follows: A grant was awared to scholarship recipient Bernice Forte, in the amount of \$357.00; the packet for Spring Enrollment was received; and inforamtion on selection of Woman of the Year. A card was received from High Street Community Education from the three families that were given Christmas baskets. A letter from the Capitol Arts Commission was read asking for chapter support in the form of a donation.

As Sandra Perry, corresponding secretary, will be attending college on the evenings of the monthly meetings, Angie Yokley will resume her duties.

Reports were made from the standing committees as follows:

Bulletin: Mary Hext stated she is still trying to locate past bulletins in order to have permanent records on file of all the chapter's bulletins.

Hospitality: Mimi Burr announced that Leanne Lockhart had her baby which was a boy. At the February monthly meeting, she will have a report to present to the chapter on suggestions and prices of dinner meeting locations.

Membership: Kathy Lyon called the roll. She also announced that she is glad to have as co-chairman, Mary Hines. At the February meeting she will be handing out the Hand of Friendship forms to all members for the upcoming Spring Enrollment Event.

Education: Christy Branstetter had received much appreciation from the three scholarship recipients and announced that Bernice Forte had received a grant from National.

Ways and Means: Jan Weaver and Dale Huyck briefed the chapter on the Christmas baskets that were given to the three families. The names were taken from the Head Start Program. The committee is working on getting a small appliance donated for a raffle.

Special committee reports are as follows:

Woman of the Year: Brenda Keith passed out forms to be turned in to her by February 15, 1983. The forms must be typed and can be submitted on yourself or another chapter member. A committee will review all the applications and submit to the chapter those forms at the February meeting for election of the Woman of the Year for 1983.

Spring Enrollment: Robert Lawrence will have a date set to be announced at the February meeting for the upcoming event to be held in March.

Business Associate Night: Michele Neal will be chairing this event. A motion was made by Peggy Sharer, seconded by Mimi Burr, that she and her committee try to have the banquet at the country club on May 21, 1983. A more detailed report will be given in February.

President Michele Neal brought up discussion of the third fund account. a motion was made by Mimi Burr for the Souvenir Ad Program and the Fashion Show projects funds to be deposited into the savings account for scholarships and the regular account, and the third account be funded by the craft auction and other small money making projects which would be for convention expenses and educational advancement of members. Motion was seconded by Peggy Sharer but was withdrawn after discussion.

A motion was made by Pat Cole stating that a special third account be established and to be earmarked for convention and educational advancement of members to be funded by the craft auction and all other money making projects proceeds go into the regular account for scholarships and operating expenses unless so designated by chapter vote to go into the special third account. This motion was seconded by Gwynne Hammond, and the motion carried. The beginning balance for the third account will be \$118.81.

The benediction was given by Christy Branstetter. The meeting was adjourned at 8:35 p.m.

The Executive Board of the Kentucky Colonel Chapter met at the Warren County Board of Education office at 5:15 p.m. January 18, 1983. Members in attendance were: Michele Neal, Vickey Branstetter, Sandra Perry, and Karen Towell.

Karen Towell, treasurer, reported on the checking and savings accounts. The third treasury fund was discussed. After discussion, the board agreed to make the following recommendations to the chapter at the January meeting:

No response has been received from the Hospitality Committee on the status of the locations for the chapter's dinner meetings. A report will be given at the January meeting.

Sandra Perry, corresponding secretary, stated that she will be taking evening classes on Tuesdays in order to finish her degree and will be unable to fulfill her responsibilities for the remainder of the year. The board appointed Angie Yokley to serve as corresponding secretary for the remainder of the term.

The meeting was adjourned at 6:00 p.m.

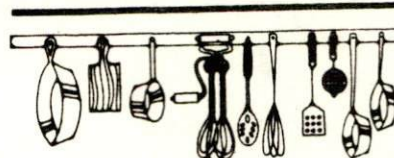
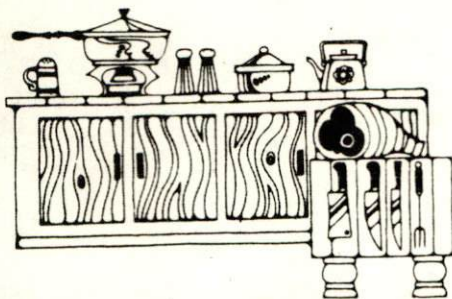

CRAB MOUSSE

- 1 can tomato soup
- 1 1/2 T. unflavored gelatin
- 1 c. mayonnaise
- 1 large pkg. cream cheese - soft
- 1/2 c. scallions
- 3/4 c. celery, chopped fine
- 1 can crab meat

Grease mold. Soak gelatin in crab liquid. Heat soup to boil and add gelatin. Soften cream cheese and add hot soup. Blend well. Add mayonnaise, celery, and scallions. Season if necessary. Wait til mixture thickens a bit, then pour into mold, alternating with crab meat.

(I just mix mine altogether rather than layering, and I also add some tobasco for flavor.)

CHOCOLATE COVERED BANANA

- 1 t. unsweetened cocoa
- 1 t. brown food coloring
- 1/2 t. coconut extract
- 1/2 t. lemon juice
- 1/2 t. butter flavoring
- 1 medium banana, peeled, cut in half and frozen
- 1 T. water
- 1/2 t. vanilla extract
- 1/3 c. non-fat dry milk
- Artificial sweetener to equal 4 t. sugar

Combine the cocoa, coloring, extracts, flavoring, and lemon juice. Add water, milk and sweetener. Pour over frozen banana and return to freezer. Serve frozen. Divide evenly. Makes 2 servings. Each serving is equivalent to: 1/2 t. cocoa (1/2 serving something extra), 1/2 c. skimmed milk (1/2 milk serving) and 1 fruit.

CHICKEN DIVAN

- 3 chicken breasts
- 2 pkg. broccoli spears
- 1 can cream chicken soup
- 1 can cream celery soup
- 1 can mayonnaise
- 1/2 c. chicken broth
- 1 Tbs. lemon juice
- 1 can (4 oz.) mushrooms (drain)
- 1 pkg almonds
- dash cooking sherry
- buttered cracker crumbs
- 1 c. shredded cheddar cheese
- 1/2 t. curry powder

Cook chicken. Reserve 1/2 c. broth. Break into bite size pieces Place cooked broccoli semi-tender in 9 x 13" pan. Cover with chicken. Mix soups, chicken broth, mayonnaise, lemon juice, curry powder, mushrooms, and almonds. Pour over chicken. Add cheese (8 oz.) by sprinkling. Cover with buttered cracker crumbs. Bake at 350° for 30 min.
