**PURPOSE:** To amend the Associated Student Government Constitution in the below sections, articles, and adding new sections and articles.

Amendments as follows:

1. Change Article II. , Section 2.A, 4, from President and Administrative Vice-President to all executive officers, and add after faculty member , "or graduate assistant."
2. Change Article III. , Section 4.E, by adding a representative from the Community College and College of Education and their alternates.
3. Change Article III. , Section 4.I, by striking "two freshman" to make it "four (4) freshman representatives."
4. Change Article III. , Section 4, by adding a (k) section as follows:
  - K. A representative from the following university organizations: Resident Hall Association and the University Center Board.
    1. Each of the above organizational representatives shall be elected or appointed among the respective organizations each spring to serve one academic year in ASG.
    2. Each organizational representative shall have all the rights and responsibilities of any other congress member.
6. Change Article III. , Section 5.A, by adding after "faculty member", or "graduate assistant."
7. Change Article III. , Section 8, to strike out the words "Presidential Appointment" and inserting the words "Executive Council recommendation."
8. Change Article IV. , Section B.1, by striking out, "President" and inserting "Executive Council."
9. Change Article IV. , Section B.3, by striking out, "Chairman of the Judicial Council", and inserting "Chief Justice."
10. Change Article IV. , Section B.3, A, by striking out "President" and inserting "Executive Council."

11. Change Article IV. , Section B.4, 5, 6, rename 4, 5, 6, to 5, 6, 7, and adding a new section 4. as follows:
  4. The Attorney General shall be vice-chairman of Judicial Council:
    - A. be appointed by the Executive Council of the Associated Student Government from the seven (7) regular members with the approval of 2/3 vote of the full membership of congress.
    - B. be the vice-chairman of Judicial Council
    - C. Serve as Ex-officio advisor to the Rules and Elections committee.
    - D. to help carry out election process and varify the validity of the election results.
    - E. to have the power to enforce the Bylaws and Constitution of the Associated Student Government.
    - F. to have the power to call the Judicial Council into session.
    - G. to ask for a ruling on any matter concerning the Associated Student Government.
    - H. to perform all other duties assigned by the President.
12. Change Article V. , Section 1. , to read, "There shall be a Legislative Research Committee."
13. Change Article V. , Section 1.A.1, by striking "other Congress Members appointed by the President of ASG" to read , "any other Congress Members or non-congress members wishing to serve."
14. Change Article V. , Section 1, by adding:
  - B. The Executive Council shall appoint a chairman of "Legislative Research Committee" with a simple majority of congress.
  - C. The Executive Council shall appoint a vice-chairman of "Legislative Research Committee" with a simple majority of congress.
15. Change Article V. , Section 2, to read: "There shall be a Rules and Elections Committee."
16. Change Article V. , Section 2.C, by striking out "President of the Associated Student Government" and "from congress" and adding "Executive Council."
17. Change Article V. , Section 2.C, by adding the following subsection:

1. The chairman and vice-chairman of the Rules and Elections Committee may not serve as chairman or vice-chairman if seeking executive office.
  2. members of the Rules and Elections Committee may not serve on the committee if they are opposed for congressional or executive office during the spring elections.
18. Change Article V. , Section 2, by adding a D. as follows:
- D. the Executive Council shall appoint a vice-chairman of Rules and Elections Committee with a simple majority of congress.
19. Change Article V. , Section 3, to read: "There shall be a Student Affairs Committee."
20. Change Article V. , Section 3,B.1, shall read: "Be composed of class vice-presidents and other congress members and non-congress members wishing to serve."
21. Change Article V. , Section 3.C, shall read "The Executive Council of the Associated Student Government shall appoint a chairman of the Student Affairs Committee with a simple majority approval of congress."
22. Change Article V. , Section 3, by adding the following subsection D:
- D. The Executive Council shall appoint a vice-chairman of Student Affairs Committee with a simple majority of congress.

## STATUS:

WHEREAS; The Constitution has many badly worded clauses that cause confusion; and

WHEREAS; The Community College goes unrepresented, and

WHEREAS; The freshman class is not represented equally, and

WHEREAS; The Judicial Council has made recommendation on how to improve the election process, and

~~WHEREAS; The President of the Associated Student Government is required to have a 2.75 G.P.A. to serve on the Academic Council, and~~
