

MINUTES FOR OCTOBER 5, 1912.

A called meeting of the Board of Regents was held at Bowling Green, Kentucky, at 10 A. M., October 5, 1912, at which were present Messrs. J. W. Gooch, H. K. Cole, and J. Whit Potter. The Chairman stated that the meeting was called for the purpose of signing the issue of \$100,000.00 bonds and completing the transaction.

The bonds were signed and sealed, and the local Regent was empowered to complete the transaction with Seasongood & Mayer of Cincinnati, Ohio, and to secure the funds at the earliest possible moment.

It was moved, seconded, and carried that the President and the Local Regent be instructed to place immediately enough insurance to comply with the requirements of the mortgage, approximately as follows:

MINUTES FOR NOVEMBER 1, 1912.

Present Regents Barksdale Hamlett, State Superintendent of Public Instruction, Hon. J. W. Gooch, and Mr. J. Whit Potter. Meeting at the office of President H. H. Cherry.

Superintendent Hamlett occupied the chair and called the meeting to order.

compared by Hon. C. U. McElroy, his attorney, appeared before the Board, when Mr. Bornstein presented his case. After a lengthy consideration and upon motion of Mr. J. W. Gooch, seconded by Mr. Potter, it was unanimously agreed that Mr. Jacob Bornstein be paid \$2,000.00 (Two thousand dollars) additional, in full of all claims and demands of every character of Bornstein upon the school Board, for the erection of the Auditorium building and other work, Mr. Bornstein being present and represented by his attorney, C. U. McElroy, and then and there agreeing to accept the said \$2,000 in full of settlement of all claims of every character against the Board.

Mr. Potter reported to the Board that the contract for coal had been placed with the Bevier Coal Company, Cleaton, Kentucky, as follows:

Nut Coal-----\$2.32-1/2 per ton put in coal houses.

Lump Coal-----\$2.52-1/2 per ton put in coal houses.

President H. H. Cherry submitted an estimate of the approximate expenditures for the next year as shown by the detailed statement entered herein; whereupon Mr. Potter moved that there be an expenditure allowed for these needs, the amount not to exceed \$14,650. Seconded and carried.

Mr. Gooch moved that President Cherry and the local Regent be authorized to put in such glass in the Auditorium as in their judgment is necessary to repair any breakage.
