Now if it shall always hereafter appear, that there is no lawful cause to obstruct said
marriage, then this obligation to be void, otherwise to remain in full force & virtue.

THE condition of this obligation is such, that if there should be no legal cause to obstruct a marriage shortly intended to be solemnized between the said Thompson son of Elizabeth Thompson & Sarah Barnell daughter of said James Barnell

Then this obligation to be void, else to remain in full force and virtue.
