Dr. Cherry made a statement to the Board relative to the issuance of \$309,000 of bonds, the proceeds to be used in con-

struction of the classroom and laboratory building. He stated that following the meeting of January 25th, at which time the Board accepted the offer of a grant and loan from the PWA and ordered the issuance of the bonds, that a number of bond dealers had requested that the matter be reppened and that they be allowed the oppor-qu tunity to buy these bonds, and that he had conferred with the PWA officials and they offered no objections to the sale of bonds at private sale. He further stated that he had written and caused to be written letters to each of the bond houses who had made inquiry stating that the matter would be brought before the Board at this meeting for action and that representatives from several of these firms were in the antercom, desiring to enter bids for the purchase of the bonds. After discussion, it was moved by Senator Bartlett that these gentlemen be invited before the Board; that the Board hear what offers they had to make and that their propositions be afterwards discussed and acted upon in executive session. Motion was seconded by Senator Franklin and unanimously passed.

The Chairman invited all interested in bidding for the purchase of these bonds to come before the Board.

An offer was made by a syndicate composed of Almstead Brothers, Bankers Bond Company, and J. J. B. Hilliard & Son, all of Louisville, Kentucky, to purchase these 4% bonds at par, accrued interest and premium of \$1500.00. This bid was to be unconditional and subject only to release of PWA.

A syndicate composed of Magnus & Company, Walter-Woody and Heimerdinger & Company, A. Hinsch & Company, of Cincinnati, proposed to purchase this issue of bonds if the bonds could be issued on a \$\frac{1}{20}\$ coupon rate at a price to yield \$3.85, or approximately \$946.00 for each \$1000 bond, all subject to approval of attorneys.

The Board went then into executive session and after discussion, a motion was made by Judge Hines to the effect that all propositions for the purchase of the bonds be rejected, and that the issue be sold to the United States Government as originally ordered. Senator Franklin seconded the motion. Upon roll call, Regents Bartlett, Hines, and Franklin, and Chairman Peters voted aye and the motion was declared passed.

President Cherry stated that it was desirable to obtain an Alcohol Permit for the purchase of tax free alcohol to be used in the laboratories. Regent Franklin moved, seconded by Regent Bartlett, that a permit be requested and that Miss Florence Schneider be given Power of Attorney by the Board for the handling of such purpose.

President Cherry reported that he had not been able to secure a contract from the Kentucky-Tennessee Light and Power Company

for electrical service - that the company demanded a four year contract. Regent Bartlett suggested this matter be left open and tol the officials be directed to insist on a two year contract. Molescope
