COLLECTION NOTE

This collection documents "Folklorists in the Parks," a joint project of the Kentucky Folklife Program and the Kentucky Department of Parks. Folklorist Bruce Baker conducted fieldwork among folk artists and performers in Powell, Wolfe and Lee Counties, near Natural Bridge State Resort Park. Their work was then showcased in public programming at the park. Bluegrass music, tobacco culture, furniture making, farming, religion, the oil industry, the timber industry, quilting, pranks, foodways, death customs and the local beverage industry were a few of the traditions discussed during recorded interviews. This collection includes fieldnotes, promotional materials, and audio interviews on cassette tapes with traditional artists. Administrative papers include correspondence, grant papers and programming helps. There is an audiocassette tape (#33) in this collection which is not included in the tape log.
