MINUTES

Meeting
Council of Academic Deans
March 3, 1992

Dr. Robert V. Haynes called the meeting to order at 9:00 a.m. Members present included Drs. Michael B. Binder, Carl R. Martray, J. Michael Brown, Ronnie N. Sutton, Elmer Gray, Charles E. Kupchella, John H. Petersen, and Livingston Alexander.

Dr. David Lee represented Dr. Ward Hellstrom.
Mrs. Freida Eggleton was present as a guest.

The minutes of the February 25, 1992, meeting were reviewed and approved.

Dr. Haynes opened the meeting by announcing that Western has an opportunity to receive a Community Service Act grant totaling \$20,000 (with a requirement to match that amount). He sought feedback from the Council as to the name of an individual who might coordinate the project. Since the project would have a relationship to KERA, it was suggested that the coordinator be a member of the faculty in the College of Education and Behavioral Sciences.

Dr. Haynes then informed the Council that the University had budgeted a total of \$164,000 for waiving out-of-state tuition for graduate assistants over the last few years and that that amount was grossly inadequate. He sought feedback from the Council as to the appropriate balance of in-state and out-of-state (including international students) graduate students who receive graduate assistantships. Following a discussion of the issue, Dr. Haynes asked Dr. Gray to incorporate the feedback in a recommendation.

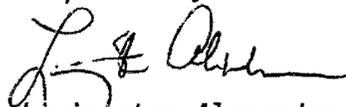
Dr. Haynes then called on Mrs. Eggleton to discuss a Proposal for College Receptions which would be implemented following the 1992 commencement. Following an extended discussion, the Council endorsed the proposal. Dr. Haynes asked that each college dean provide to Dr. Sutton the name of an individual who would serve as a member of the Reception Committee.

Dr. Petersen shared with Council members a copy of a revised format for presenting the Fall Indices. Deans were asked to share the format with department heads and to prepare to discuss it at the next meeting.

Finally, Dr. Haynes provided a report on an ongoing discussion related to the 1992-93 budget.

The meeting was adjourned at 12:10 p.m.
