From this data, a project summary was compiled that included information about cultural resources within the county. Included in the summary was information related to agriculture, faith, crafts, music, and country stores. The project summary also includes a brief county history as well as information about the various informants. Most of the research collected for this project was done by Elizabeth Campbell, who acted as Owen County folklorist for twelve weeks while conducting the project. She was assigned to the county as part of a Cultural Economic Initiative grant from the Kentucky Arts Council.
