COLLECTION NOTE

The collection consists of ordinances passed by the relevant authority of the City of Bowling Green, Kentucky from 1914 to 1944. The ordinances are generally typed copies which have been signed by the Mayor and attested by the City Clerk. Box 1 (Folder 1) contains a chronological list in which the subject of the ordinance is briefly described. The collection also includes (Box 3) deeds and easements granted to the City of Bowling Green spanning the years 1885-1968; most are copies bearing original signatures and recording information. Other miscellaneous documents include resolutions (Box 3, Folder 6), budgets (Box 3, Folder 7), and contracts and agreements (Box 3, Folder 9).
