***BIOGRAPHY***

Joseph Rogers Underwood (1791-1876) was born in Goochland County, Virginia, the eldest son of eight children of John Underwood and Frances (Rogers) Underwood. In 1803, he moved to Barren County, Kentucky, with his maternal uncle, Edmund Rogers. Underwood attended various local schools, graduated from Transylvania University in 1811, and later studied law under Roger Wickcliffe. Enlisting in the army in 1813, he was wounded at Dudley's Defeat at Toledo, and returned to Kentucky embarking on his law career. From 1816 to 1820, Underwood represented Barren County in the state legislature. In 1817, he married Eliza M. Trotter (1800-1835), the granddaughter of the noted Methodist preacher David Rice, by whom he had eight children. Eugene, Julia, Eliza "Light," and Jane were the only children who lived to adulthood.

In 1823 Underwood moved to Bowling Green, Kentucky, and was chosen a presidential elector on the Clay ticket in 1824. He was elected to the state legislature from Warren County in 1825, but was defeated when he ran for lieutenant governor in 1827. Underwood was appointed an associate justice of the Kentucky Court of Appeals in 1828 and served until 1835. He was then elected to the U.S. House as a Whig Representative, serving from 1835 to 1843. In 1839, while serving in Congress, Underwood wed Elizabeth Threlkeld Cox (1818-1884), a daughter of Georgetown mayor John Cox. They were also the parents of eight children.

In 1844, Underwood was a presidential elector for the Whig ticket of Clay and Frelinghuysen, and in 1845 he was elected to the state legislature and served as Speaker of the House until 1847 when he was elected to the United States Senate. Underwood was not a candidate for reelection, so he resumed his law practice and farming operations in Kentucky. He served in the state legislature from 1860 to 1863, attended the Democratic Convention in Chicago in 1864, and practiced law and engaged in agricultural operations in Bowling Green, Kentucky, until his death.

Warner Lewis Underwood (1808-1872), a younger brother of Joseph Rogers, was born also in Goochland County, Virginia. He came to Kentucky when he was seventeen, but returned to Virginia for his education. Following his graduation from the

University of Virginia in 1830, he moved to Bowling Green, Kentucky, to practice law. In 1831, Underwood married Lucy Craig Henry (1816-1893) and they were the parents of ten children. While continuing his law practice in Bowling Green, Underwood visited Texas frequently, actively engaging in land speculation between 1833 and 1840. In 1848 Underwood was elected as a senator to the state legislature, and to the House of Representatives in 1855. He served until 1862, when President Lincoln appointed him as consul to Glasgow, Scotland. The family returned to the United States in 1864, living in San Francisco for two years, and in 1866 they moved back to Bowling Green, Kentucky.

John Cox Underwood (1840-1913), the eldest son of Joseph Rogers and Elizabeth Cox Underwood, was born in Georgetown, D.C. He grew up in Bowling Green, Kentucky, and received his early schooling there. At the age of fourteen, John Cox attended high school in Illinois and later graduated in 1862 from Rensselaer Polytechnic Institute with a degree in civil engineering. He was the only member of his family to embrace the Southern cause in the Civil War. He served as military engineer in Virginia in 1862, joined General Bragg's command at Tullahoma, Tennessee, where he contracted typhoid fever, and was captured by the Federal Army upon Bragg's retreat in the spring of 1863. John Cox was imprisoned in Cincinnati and Boston, but finally obtained a parole from President Lincoln. He returned to Bowling Green and in 1868 became city engineer. Later he served as a member of the city council as well as mayor. In the state political arena, John Cox was elected lieutenant governor in 1875. Following his term, he sought the governorship but was defeated. He then entered the field of journalism, owning newspapers in Bowling Green, Louisville, and Cincinnati. John Cox's interest in genealogical research was his all-consuming endeavor during his later years.

### **THE COLLECTION**

The collection consists chiefly of the correspondence of Joseph Rogers Underwood, his wife, his children, and his brother Warner Lewis Underwood; other

Rogers family members; genealogical research; and the writings of John Cox Underwood. The materials are divided into three series with Series I containing the Joseph Cox Underwood family papers dating from 1791 to 1896 (446 items). The majority of the letters are those of Underwood and his second wife, Elizabeth Cox, covering the period 1849 to 1853, which included his last four years as a U.S. Senator from Kentucky. Series II comprises the papers of the Warner Lewis Underwood family dating from 1826 to 1902 (12 items), and includes diaries, a journal, Bible records, a passport, and a few letters. Series III includes the writings of John Cox Underwood dating from 1863 to 1912 (411 items); several holographic and typescript manuscripts of his writings and genealogical notes; and correspondence that concentrates on his associated families, especially the Rogers family, which he incorporated in his book, *Lineage of the Rogers Family*.
