BIOGRAPHICAL NOTE

Born in Hopkins County, Kentucky on 16 September 1878, Maurice Kirby Gordon was the son of William Leonidas Gordon, a Madisonville attorney, and Cordelia Adeline Arnold. He was admitted to the bar of Kentucky in September 1898 and entered the practice of law in Madisonville. On 19 October 1899 he married Mary Howard Nisbet (1874-1952) in St. Charles, Kentucky, and they became the parents of a daughter, Mary Nisbet Gordon, born 11 December 1918.

In 1915, Gordon enlisted as a private in the Kentucky National Guard, saw service on the Mexican border in 1915-1916, and rose to the rank of captain. During World War I, he served as Inspector General of the 36th Division, American Expeditionary Force. Gordon participated in the organization of the American Legion at Paris, France, and is credited with suggesting the name for the new veterans' group. Discharged in 1919 with the rank of major, Gordon returned to law practice in Madisonville, where he worked primarily as an attorney for various local banks, coal companies and other corporations. Gordon continued his involvement with the American Legion and received an award for distinguished service shortly before his death. He was also an enthusiastic collector of books, manuscripts and autographs, and conducted extensive genealogical research on the Virginia families from which he was descended.

Maurice Kirby Gordon died in Madisonville, Kentucky on 4 September 1974.

This collection consists of the personal and professional papers of Maurice Kirby Gordon. It includes materials in the following categories:

- a. personal correspondence and photographs, including materials relating to Gordon's military service, involvement in the American Legion, research on Hopkins County, Kentucky history, and his family and business affairs;
- b. professional files from Gordon's legal practice (primarily in Boxes 42-129);
- c. genealogical research and correspondence;

- d. collected manuscripts and autographs, and associated research material; and
- e. miscellaneous printed matter, including prints and maps.
