COLLECTION NOTE

Rickie Z. Ashby, a native of Ohio County, amassed this material as he worked on various historical and genealogical research projects. The chief focus of the collection is the vigilante group known as the Possum Hunters, which operated in the first quarter of the twentieth century in various western Kentucky counties, chiefly Butler, Muhlenberg, Ohio, and Daviess counties. A great deal of the material in Box 1 relates to Commonwealth or Ohio Circuit court cases involving the Possum Hunters (Folders 2-16), interviews with Possum Hunters or people familiar with them (Folders 17-20), news clippings about the group (Folder 21), and a paper by Ashby about the vigilantes' reign of terror (Folder 23). Folder 22 contains a small number of photographs and illustrations related to the Possum Hunters and other topics of interest to Ashby. The other folders in this box relate to violence in western Kentucky with particular reference to the Night Riders, who were generally active a decade prior to the Possum Hunters.

Box 2 includes other files related to Ohio County and broader Kentucky historical themes. Folder 1 includes news clippings related to Ohio County history. Folders 2 through 9 relate to biographical or genealogical material of people or families from western Kentucky, again with an emphasis on Ohio County. Folder 10 includes a few news clippings related to the history of education in Ohio County and a lengthy paper titled "Education in Ohio County, Ky. During the Transitional Era, 1860-1920." Folder 11 includes a typescript titled "A Trip to Dixie" by Thomas S. Petit and edited by Ashby. It chronicles an 1864 trip from Owensboro, Kentucky, where Petit was editor of the *Monitor* newspaper, to Memphis, Oxford, Mississippi, Charleston, South Carolina, and eventually Richmond, Virginia. The location of the original is not noted. A paper titled "The Fortification of Bowling Green During the Civil War, 1861-1865" by Kenneth C. Wolfe can be found in Folder 13. A photocopy of Henry Clay's will is housed in Folder 14.
