Includes mercantile accounts, legal papers and obituary of James Nicholls; Emma's temperance pledge and WCTU leaflet: letters to her regarding some inherited Texas land; a photocopy of a family photograph; and a letter to Emma from her husband's former store clerk repaying money improperly taken. Also includes Emma's letters to her two daughters at school consoling them over illness caused by a vaccination; and invitations to the daughters' weddings, given by their grandmother after Emma's death.
