**COLLECTION NOTE**

This collection consists of research material, National Register nomination forms, Historic Resources inventory forms, photographs, slides and negatives documenting historic vernacular architecture in Kentucky. The materials were assembled by Dr. Albert J. Petersen, a professor of geography at WKU, and his students. The collection contains data on historic structures from 85 Kentucky counties; in addition, Box 19, Folders 1 and 5 contain, respectively, slides of courthouses, and National Register nominations for prehistoric art sites located in some counties that are not otherwise represented in the collection.
