BIOGRAPHICAL NOTE

James R. Hines, the son of Jett Walton Hines and Ida Mae Williams, was born in Evansville, Indiana on 6 May 1903. As a child, he was given the nickname "Jimmie D." after James Davis Hines (1838-1911), a distant relative whom his father admired. From an early age, Hines became familiar with steamboat operations on the Green, Barren, and Ohio rivers. Both his father Jett and his maternal grandfather Richard T. Williams were steamboat captains, and Hines took his first job at age thirteen on a sidewheeler steamboat on the Ohio River.

Hines attended school at Ogden College in Bowling Green, Kentucky, and in 1925 earned a law degree from Cumberland University in Lebanon, Tennessee. He became licensed to practice law in Florida, Indiana and Kentucky. In 1928 Hines opened a law office in Morgantown, Kentucky, then moved his office to Bowling Green, where he became engaged in the bargeline business. In 1940, Hines and an associate formed the partnership of James R. Hines and Company to transport asphalt and petroleum products. Other bargeline and towboat operations, both partnerships and corporations, followed, including James R. Hines Corporation (1946) and Penlatex Barge Line, Incorporated (1962).

In 1955, Hines's two sons, James G. Hines and Warren W. Hines, formed Hines, Incorporated, which became the largest of the "Hines Group" of businesses. In 1977, after Hines, Incorporated purchased James R. Hines Corporation, Hines ceased to be personally involved in the bargeline business and confined his role to serving the company as counsel.

Hines's family background and livelihood gave him a deep interest in the history, resources, and economic fortunes of the Green River Valley. He was the first president of the Green River Valley Citizens League, organized in 1951 to advocate for flood-control dams, navigational improvements, and development of resources to enhance economic growth and employment in the region. He was a founder of the Barren River Development Association and a member of the Propeller Club of the Port of Louisville, the American Petroleum Institute, the American Waterways Operators, the Ohio Valley Improvement Association, and the Mississippi Valley Association, and served on the board of First Federal Savings and Loan Association in Bowling Green.

Hines married twice: to Clarice (Griffith) Crow (1907-1997) and Flora Gertrude Whitaker (1915-1985). He died on 23 September 1995 and is interred in Bowling Green's Fairview Cemetery.

COLLECTION NOTE

This collection consists primarily of materials created and collected by James R. Hines relating to his bargeline businesses, his interest in the Green River Valley, and his advocacy for improved river navigation facilities. Much of Hines's writing consists of statements and submissions addressing the need for various improvements on the Green River such as locks and flood-control dams. Among the more comprehensive addresses is a statement (Box 1, Folder 7) for consideration by the U.S. Corps of Engineers in a 1970s study to determine the feasibility of completing the Green River Valley Program to extend navigation on the Barren and Green Rivers. Hines provides context and a general overview of the development of the river, its importance to the local economy, and the federal government's failure, in his view, to live up to its commitments regarding navigation and flood control. These undated writings are in both handwritten and typescript form, and many are drafts or fragments and are duplicative in content, but they display the breadth of Hines's historical and technical knowledge and the strength of his advocacy. At times, he weaves his own family history on the Green River into the narrative; at other times, his frustration lends itself to wider critiques of government regulation and economic policy, monopolies, and competition from the railroad industry.

Other writing (Box 1, Folders 3, 5, 6) specifically takes the form of a planned memoir in which Hines (known as a talented storyteller) relates incidents of his family and youth on the river. He also writes of his early years as a lawyer, describing cases in which he was a reluctant criminal defense attorney and a player in the windup of an insolvent Butler County bank.

Correspondence (Box 2, Folders 1-5) relates mainly to Hines's business affairs and advocacy for the Green River Valley. He writes congressmen, senators, presidents, and even President Jimmy Carter's daughter Amy, about policy, proposed legislation such as the Surface Transportation Act of 1971, and water pollution.

The collection also includes a small amount of material relating to Hines's brother J. Omar Hines (a 1965 mortgage and 1975 funeral service program); another brother, William E. "Bill" Hines (an insurance policy with some personal data); and Bill Hines's son William E. Hines, Jr., and his attempts to find government employment (Box 2, Folder 15).

Other items of interest include family steamboat operator licenses (Box 1, Folder 4); and an issue of *S&D Reflector* (March 1970), published by the Sons and Daughters of Pioneer Rivermen and containing well-illustrated articles about steamboating.
