Rules for Awarding of Loving Cup to Student Adjudged Most Representative Student in Bowling Green Business University

This cup shall be called the BETTY AUSTIN CUP, so named in honor of my wife, and is offered as an incentive for higher and greater endeavor.

✓ Each faculty member may submit one or more names of students of the Bowling Green Business University whom he considers to be proper candidates for this cup. This shall be done at or before the second regular faculty meeting in May. These names shall be turned over to a committee of two, appointed by the chairman of the meeting. This committee shall check the school records as to the scholastic standing of the candidates to see that they are properly qualified as hereinafter pointed out.

✓ At the next meeting these names shall be submitted to the faculty to be voted on. It shall be for the faculty to decide whether they wish to vote orally or by secret ballot.

✓ To be elected, a candidate must receive a majority of the votes cast. If no candidate receives such majority on the first ballot, then the names of the two candidates receiving the lowest number of votes shall be stricken and a new vote taken (except that where there are only three candidates, one name only shall be stricken).

In case there should be a tie in the number of votes received by the last two remaining candidates, then the cup shall go to the student having the higher scholastic standing. In determining this standing, it shall be considered that each final grade of A shall have a weight of ~~three~~^{four}, each B a weight of ~~two~~^{three}, and each C a weight of one. This weight shall be multiplied by the number of semester hours of credit the course counts (Thus one A on a three-hour course counts ~~12~~¹² points, etc.).

Qualification of Candidates--

✓ Any regularly enrolled student of the Bowling Green Business University (college or non-college division) at the time of the award shall be an eligible candidate for this cup.

✓ The candidate shall be selected because of his scholarship, leadership, character and initiative.

Scholarship--each candidate must have a scholastic standing of B or higher in grades.

Leadership--I think that a student is more representative if he participates in the various school activities such as state clubs, debates, athletics, etc.

He need not be an officer in one of these clubs, although if he is this fact shall be considered as in his favor.

Character--general conduct while away from school and while in the classroom.

Initiative--the willingness with which he works and his ability to carry on his work without the prodding of a faculty member.
