Faculty Meeting January 22,1912

Miss Garth is very weak in all of her studies except Domestic Science. It is hardly likely that she will complete the Life Certificate Course.

Mildred Crenshaw has dropped out of her classes. Dr. Kinnaman will write her parents.

Mary Dobson belongs to the same class as the above. Also Vesper Smithson, Helen King, I.H. Nance, Ethel Hansford, and Edna Bell.

It was agreed that it was the sense of the faculty that the city Book Stores should be notified by Prof. Green one term ahead in case of any change in text books in order to accommodate these firms. This is not to apply to any department where books are taken off the hands of the book dealers by the different companies.

It was moved, seconded, and carried unanimously that the gift to the Normal School Library by Mr. Robert Dulaney of about two hundred volumws—the remnant of Judge Dulaney's library—be accepted and resolutions of appreciation be drawn up and presented to him. Miss Florence Ragland and Mr.W.J. Craig were appointed to prepare the resolution and present it at Chapel.

January 30, 1912.

Faculty met in regular aession. The work of organizing the student-body by counties was discussed and put into execution.

By motion it was agreed to issue to T.H.Likens who has completed a considerable amount of work beyond

the course, the Elementary Certificate.

Miss Mary Crutcher having last week completed the work that she had last year failed to bring up on the Senior course, is entitled to the Certificate from that department. Dr. Kinnaman has written her to that effect.

Minutes Faculty Meeting Feb. 5,1912

Dr.Kinnaman requested and urged that absentees be reported to his office, at the end of two days. By waiting longer than this, there is danger of losing the students.

The question of caring for the sick student was brought up. Professor Alexander ,as Chairma of this Committee instructed that the blanks would be left in the side room off the stage where they can be filled out by teachers or students hearing of sickness.

Dr.Kinnaman was asked to announce at Chapel that students can take the county examination here and have their papers forwarded to home counties for grading, etc.

Too much noise in the halls of the Recitation building. Students are missing chapel too much. Frewwently they remain in their boarding homes because, "I don't have a class before Chapel and don't come. The teachers were asked to stress this point in their classes.

Faculty met in regular session April 22,1912 Moved ,seconded and carried that MissMary Browming be allowed to substitute work in Oratorio for work in Music required in the Life Course.

Same that MissGabie Robertson be credited with Composition.

The matter of Miss Mildred Coffman's completing the Elementary Course was referred to the Dean.

The case of P.M.Basham was then taken up, and it was decided that he be allowed to substitute for Music 1 and Music 2, English 1, and Method in Reading, the following: Agriculture 1 and 2, Algebra 3 and Arithmetic 3.

Tom Hamilton was allowed to substitute Latin 1, Biology 1 and 2, and Algebra 3 instead of Nature Study, Geography 2, and Technical Observation.

The faculty contributed ten dollars for the floral offering sent to the family of Capt. C. J. Vanmeter.

February 3, 1913.

The list of students who failed to re-register for the Mid-Winter Term was read, and the different members of the faculty reported the cause of the absence of most of them.
