### November 10, 1913.

Moved and carried that school be in session all day Friday, November 14th.

Moved and carried that the Christmas holidays begin von December 19th, and close on December 30.

Prof. Craig was made chairman of the committee to arrange for Good Roads Day Thursday, November 13th.

Moved and carried that the \$10 appropriated by Mr. J. E. McFerran, to be used for the work done by the Western Normal on the Good Roads Day, should be spent in the purchase of rock to be employed in perfecting the piece of road worked by the students.

Miss Iva Scott, in the School of Domestic Science, was asked to prepare lunch for the young men who did work on the road. Members of the faculty and young women students volunteered to help.

Arrangements were made for the Greater Warren County Convention, the school to co-operate with the citizens of the town in the barbecue offered by the citizens to the rural people and other visitors. The faculty subscribed between \$100 and \$150 as their contribution and offered their services to aid in the work.

## December 7, 1913.

The date heretofore set for the Christmas holidays was reconsidered and it was agreed that the school be dismissed on December 23rd and resume work again on January 2nd.

# January 5, 1914.

Moved, seconded, and carried, that Miss Eskridge be allowed to change her work from Biology to Agriculture, and Prof. Leiper was granted the privilege of trying a new Grammar in his department.

Upon request from Miss Frazee, she was allowed to use as supplementary pamphlets two Methods in Primary Reading. Also two Reading Manuals for new course in Primary Reading.

Moved and agreed that Method I (English) be moved out  $\nu$  of the Senior course and put into the Junior Course.

### October 13, 1913.

The date for the Commencement Sermon was set for June 7th.

It was agreed to set apart Friday and Saturday, October 24th and 25th, to be used in accordance with the proclamation of the Governor, as Good Roads Day. The plan for the work is to be prepared later.

The following names were suggested as excellent names to be considered for speakers for Commencement: -- President Jenks, Wm. Hyde Bailey, Hugh Black, Allen G. Hall, Bishop Gailor, Morris Shepherd of Texas, one of the greatest political orators, Lyman Abbott, \_\_\_\_\_\_, Lowell of Harvard, \_\_\_\_\_\_, Henderson, of Chicago, H. Churchill King, of Oberlin.

The Chestnut Hunt was set for Saturday, November 8th.

Moved, seconded, and passed that the school furnish the books for the Oratorio another year.

### January 12, 1914.

The question of employing Gadski to give a concert and musical festival at this place, was discussed but no definite decision was reached.

#### January 19, 1914.

Moved and agreed that Mr. T. H. Likens be granted the Intermediate Certificate.

### March 16, 1914.

Moved, seconded and passed that the members of the graduating class be given the privilege of adopting the style of dress they prefer for Commencement. This to be worked out in connection with Dean Kinnaman and Prof. Green.

# May 18, 1914.

It was moved and unanimously voted that the Elementary Certificate be issued to Mr. M. T. Payton, at the present scholastic term.

It was unanimously voted that a Certificate be issued to Mr. B. C. Maxey also.

It was unanimously agreed that the Seniors be excussed from their regular class work during the commencement week beginning Thursday morning, June 4th.

A special committee of the faculty consisting of Mr. W. J. Craig, chairman, M. A. Leiper, Miss Mattye Reid, J. R. Alexander, and A. C. Burton, appointed for the purpose of arranging for some of the details connected with the Alumni Banquet, recommending that invitations to the banquet be limited to the regular members of the Alumni Association, members of the faculty, members of the present graduating class, members of the Board of Regents, and the visiting County Superintendents for 1914.

It was unanimously agreed that the annual boat excursion be given Saturday, May 23.

June 15, 1914.

It was agreed that Miss Nell Follis be awarded the Elementary Certificate at the end of the term provided she "makes good".

September 14, 1914.

Moved and agreed that Miss Eva McKendreee be granted the Intermediate Certificate, it being understood that she shall take an extra term's work of English, her letter being filed with card showing evidence of this need.

Miss Van Houten was allowed to use the Teacher's Manual of Business Penmanship in her Department.

Agreed that the Athletic Committee in conjunction with the President, be given power to work out all features connected with that phase of the work. It was the sentiment of the faculty that only about 4 games of football be arranged for this season. The Athletic Director is a member ex-officio of the Committee.

October 19, 1914.

The faculty discussed the question of typhoid fever

among our students and decided to take steps to record each case. Also cases of other communicable diseases that students might have.

## November 2, 1914.

Moved, seconded, and passed that the Dean be empowered to add such members as he desired to the Enrolling Committee.

It was agreed to close school for the Chrismas holidays on Wednesday evening, December 23d, and open on Monday morning, January 4, 1915.
