December 4, 1922.

The regular meeting of the Faculty was held in the office of President Cherry.

Mr. Leiper brought up the question of steps to take when students were absent from classes as a result of overstaying holiday time. It was discussed and agreed to make each case an individual one.

The question of grading thoroughly was discussed by Faculty and Dean, who gave some printed arguments. etc.

December 18, 1922.

The regular meeting of the Faculty was held in the office of President Cherry.

The report of the Library Committee was postponed.

It was moved and seconded and agreed that the faculty begin on February 12th and prepare a report on the five-point system of grading viz. A, B, C, D, F, furnishing a short statement of the actual percentage that fall under these groups.

January 15, 1923.

Faculty meeting was held in the office of President Cherry.

Faculty gave permission for Mr. Crabb to take his Juniors to Franklin to present a play under the auspices of the High School there. There are seven to go.

The first Thursday night of next term was set aside for them to present the play here.

School closes for the semester Friday at 4 $\theta\text{'clock}$, February 9th.

February 5, 1923.

At the request of Mr. L. T. Smith, head of the Manual Training Department, Messrs, Edwin Walker, Carl Barnes, Sam Miller, Loice Owen were given the privilege of assisting in moving the equipment from the present Library to the new quarters the next day.

It was agreed to change the enrollment semester fee from \$5.00 to \$6.00 in order to provide for aid to students in sickness.

The regulation of the amount of laboratory fees was left to a committee.

President Cherry then stated that by shifting the Library to the new quarters, there would be five additional class rooms for use at the next semester. Also new teachers. Blackboards would be ordered at once.

Mr. Don McMillan, a fine student asked through Miss Jeffreys, if the work he is doing here now is college work, which is the case; and, so he is entitled to credit for all of his high school work at Willisburg.

March 5, 1923.

It was moved, duly seconded and carried that Miss Schneider send in the list of faculty as 100% enrollment for the K. E. A. and that the membership fee of \$1.00 is to be paid to her.

March 20, 1923.

The regular meeting of the Faculty was held in President Cherry's office.

Moved by Mr. Crabb, duly seconded, and passed that the Seniors be given permission to have Friday "off".

The Committee on Absences made the following report:

- l. In case of absence from a class, the student shall present to the instructor, not later than the second day following his return to class, an excuse blank properly signed.
- 2. Instructors shall report all absences in excess of two days to the Dean, giving name of student, name of subject and day and hour of absence.
- 3. Without the Dean's approval an excuse is not valid and deduction from the grade of the students shall be made.
- 4. No excuse will be accepted for the last day of the semester.

The Report was approved.

March 26, 1923.

The regular meeting of the Faculty was held in President Cherry's office.

It was decided that the Summer School this year should be six weeks in length and that the normal load should be three subjects except in special cases.

The entrance requirement was fixed at first year of High School except where the applicant is eighteen years old or older.

President Cherry named several students whom he wanted to see and talk with about their work and conduct.

Moved by Miss Davis and seconded by Dr. Gamble that the first meeting of the faculty for target practice be set for Tuesday afternoon at 4:15.

The Student Loan Fund was discussed.

President Cherry asked that the following serve on a committee with him:

Prof. J. R. Alexander Dr. G. C. Gamble
Mr. A. L. Crabb Dr. A. J. Kinnaman
Mr. Gordon Wilson.

It was moved, seconded and agreed that the Faculty pledge to this Fund 2% of their salary for the next five years.

April 9, 1923.

The regular meeting of the Faculty was held in President Cherry's office.

Attendance at the Kentucky Educational Association was discussed and it was agreed that the school should close on Thursday night and that the excursion be run on Friday morning and return Saturday night.

April 30, 1923.

The regular meeting of the Faculty was held in the office of President Cherry.

A committee to prepare a questionnaire on a Survey of the counties in Western Kentucky was appointed to be composed of Mr. A. C. Burton, Mr. Lindlow, Mr. Loudermilk, and Miss Mason.

There was a lengthy discussion of the Superintendent's Conference, and of the proposed Foundation Fund as to whether the percent to be subscribed should be 1%, 5%, or 1/4 of 1, etc.

Mr. Crabb brought before the meeting the question of the proposed debate with State University. It was agreed to have one this year, instead of one at each place, and then to drop the custom.

Mr. Anderson requested that the members of the committee on the sale of tickets for motion picture, "A Man Without a Country" be excused from classes Tuesday. Agreed.

Mr. Ford requested that nine of his students be permitted to make an agricultural trip with him. Agreed.

May 7, 1923.

The regular meeting of the Faculty was held in the office of President Cherry.

The coming celebration of Mothers' Day was discussed and final plans made for May 11th.

May 14, 1923.

Those who are graduating will be allowed to take the special vacation which has been customary to allow Seniors heretofore but no others. This to begin Wednesday of the week before the last week of the semester.

Dr. Gamble was requested to see Mr. Diddle and have boys' record established.

May 22, 1923.

It was decided to have a moving picture made of the school.

Col. Twyman asked the Faculty to consider the advisability of depriving a student of graduation when he (after having done the required work of the R.O.T.C.) remains and does poor work, etc.

May 28, 1923.

The regular meeting of the Faculty was held in the office of President Cherry.

Moved that the grades for the semester not be given out until four o'clock Thursday afternoon of the last week. Passed.

The matter of the final examinations was left to the discretion of the teachers.

Moved, seconded, and passed that we have school all day Thursday, but that we dismiss after Chapel on Wednesday.

June 5, 1923.

The regular meeting of the Faculty was held in the office of President Cherry.

Heads of Departments expected to consider names for the different classes.

July 5, 1923.

At a meeting of the faculty of the Western
Kentucky State Normal School and Teachers College there
were present the following: Mr. A. C. Burton, Mr. Hayward

The meeting was presided over by President H. H. Cherry, as chairman. A typewritten record of a certain hearing of one Frederick C. Young, a veteran trainee of the U. S. Vetrn's Bureau and student in the college for certain alleged misconduct and insubordination, had before W. N. Shackleford, Sub-District Manager of the U. S. Veterans Bureau and others was presented and filed. After hearing the statements from certain members of the faculty and obtaining a full explanation of the situation the following motion was made and unanimously carried, upon motion of Mr. M. C. Ford, with a second by Mr. M. A. Leiper, towit:

That the conduct of the said Frederick C. Young as a student in this institution has been disobedient and contumacious, and he has been insubordinate, in that he has questioned publicly the authority and integrity of members of the faculty, publicly threatening inquiry into their motives and conduct, insinuating that certain members of the faculty were guilty of improper conduct which he intended to have exposed:

That his conduct as a student has been such as to break down in the student body, the authority of the faculty in this insinuation, and to seriously impair the effectiveness of their instruction and leadership.

That therefore the said Frederick C. Young be and he is hereby expelled sine die as a student of this institution and forbidden the benefits thereof in all respects whatsoever, or to interfere in any way with the continued

conduct and operation of this school, its teachers or pupils.

Attention was called to the tragic death of Miss Sallie McElroy, and the faculty agreed to have a floral tribute sent with expressions of sympathy.

October 1, 1923.

Moved by Mr. Craig and seconded by Mr. Wilson that the report of the Committee on student activities be read. Dr. Gamble did so, and after discussion it was agreed that we make a series of classes to meet each Thursday afternoon at 4:10, as follows:

Senior Group with Mr. A. M. Stickles.

Passed.

October 8, 1923.

It was announced by Dean Gamble that hereafter the full faculty meetings would occur only on alternate weeks, and that departmental meetings would take the place of the other meetings.

Upon motion of Mr. Leiper it was agreed that the class work on each Thursday should close for the day at 4:00 in order to allow the students time to teach their various societies at 4:10.

November 19, 1923.

The Faculty met in the office of President Cherry at the usual hour.

It was agreed that on the following Monday, November 26th, there should be a faculty meeting for the purpose of discussing records that are being made by the students.

Attention was called to the fact that the Thanksgiving holiday's would begin with the dismissal on Wednesday at four o'clock and work resumed again the following Monday.

The following plans were suggested for consideration at the regular meetings of the County Delegations: (a) Whatever effort is necessary to be made to make the County Delegation 100% contributors to the Foundation. Lists of students in attendance at this time can be secured from Mr.

Roy Seward at the College Heights Foundation office. (b)
Necessary and proposed legislation should be discussed and
proper sentiment created. Students should know their
Senators and Representatives and should also know what influence in their respective counties can be brought to
bare effectively. (c) It might be suggested that communities should offer an entertainment of some kind or a box
supper between now and Christmas for the purpose of raising
funds and making Community donations from the school to the
College Heights Foundation.

A sentiment should be made against very small donations. Several teachers suggested having \$25.00 as the
minimum, but this point must be handled with discretion.

(e) Ascertain the plans of High School graduates and, if
possible, secure their promise to attend this institution.
Possibly it would be a good idea for names of the present
Senior classes in High Schools to be collected.

Minutes of Faculty Meeting November 26, 1923.

The Faculty met in regular session in the office of President Cherry.

Announcement was made that Thursday November 28th and the Friday following would be observed as the regular Thanksgivings Holidays for the school.

President Cherry spoke about the importance of making up the future A. B. and B. S. classes and asked the heads of certain Literary Societies to make a special effort in this direction.

Minutes of Faculty Meeting

December 3, 1923.

The Faculty met in regular session in the office of President Cherry.

The good of the different Literary Societies was discussed, particularly the importance of keeping up the attendance. Upon motion of Mr. Leiper, duly seconded and passed, it was agreed that:

- 1. The leader of each Literary Society group should make a special effort not only to ascertain the plans of students who are going home for the Holidays and to urge them to work as rapidly as possible toward the A.B. course, but to insist that they aid in building the attendance from their respective counties.
- 2. That these leaders should meet and formulate arguments for influencing young men and women to remain in school continuously, where possible, and to show the many values of an education.

A request was made for a list of former Life Certificate graduates who should return for the Degree. This is ready for use of the faculty who will write personal letters to those they may select from the list.

After adjournment, Dr. Kinnaman requested most of the members to remain and brought up the matter of a wedding gift for Miss Cherry. Voluntary subscriptions were made and Miss Woods, Miss McLean, and Mrs. J. R. Alexander were requested to act as a committee to select the present.

It was moved and seconded that the Western Kentucky State Normal School and Teachers College advance the courses of Home Economics and Agriculture to four years. Motion carried.

It has been moved and seconded that the faculty as a whole make the necessary change in the present requirements so that the teachers in Home Economics and Agriculture will be able to meet the Smith-Hughes requirements. Motion carried.
