The Board of Directors of the Southern Educational Building Company met in the Privare Office of the Normal School, Jan. 8, 1901, and was called to order by Chairman Potter. A quorum was present and business' begun—order in favor of E. Nahm & Co. against Ed Smallhouse for \$100.00 is filed provided a prior claim of Capt. C. G. Smallhouse of \$100.00 is not filed against it. Motion carried that six per cent interest be allowed on all warrants from the time they were issued until they are paid. Mr. J. J. Barnes was elected to callect for ten days and after this time Byron Renfrew be empowered to collect the remainder of money subscribed by those who took stock. Col T. J. Smith is to make arrangements with the collectors.

The Board of Directors of the Southern Educational Building Company met in regular session June 21, 1901, and was called to order by Chairman Potter. The following resolutions were unanimously adopted:

RESOLVED, By the Board of Directors of the Southern Educational Building Company, that we tender Captain C. J. Vanmeter our sincere thanks for his liberal subscription to this Company and his aid extended thereto, and,

RESOLVED, Further, that in recognition of his liberality, and kindness, the building of this Company, situated on College Street, in Bowling Green, extending from the front entrance, and back, and including the Chapel, shall hereafter be known and Called VANMETER HALL, and on the stone plate over the front entrance, shall be carved the words: VANMETER HALL. On a tablet to be placed in the Chapel shall be inscribed, substantially the following: "On the site of this building, Captain C. J. Vanmeter was born. One of his many acts of generosity and kinaness was substantial aid extended to this institution, and this tablet is to commemorate that fact"

RESOLVED, Further that the Southern Normal School be requested to ellect Captain Vanmeter Chancellor of that institution, as it, as well as this Company, have been jointly benefitted by his kindly aid.

RESOLVED, Further that hereafter, and as soon as it can be done withour inconvenience, that the said Normal School be requested to have the name of Vanmeter Hall, place upon such of its literature and advertising as can appropriately be done,

RESOLVED, Further that a copy of these resolutions be presented to Captain Vanmeter, signed by the President and countersigned by the Secretary.
