#### Dear Happy:

Perhaps your office can help me on the following. I have a Japanese student here named James Oshiro. He is an American citizen due to the fact he was born in Hawaii. His parents however are now in Japan. He has attended college here since September, 1940. His source of income is his brother-in-law, Ryokei Nakamura, 380 N. King Street, Honolulu, Hawaii. This brother-in-law runs a store in Honolulu and is a Japanese subject. Jimmy has not been able to hear from him since the war began and has a feeling that the assets of his brother-in-law may be frozen. Then as I told Jimmy his relative may be in the lockup. What I am asking for is advice as to what chance there is to contact the beforementioned Nakamura and ask him if he has any further funds available to enable our student to continue to pay college fees and eat.

I am obliged to be in Lexington tomorrow for an educational conference to consider the discussions of the Baltimore conference and to decide what our Kentucky colleges can do to facilitate graduation and in general to aid national defense. I think Transylvania has gone on the quarter system, which means that yours and Walter's credits in semester hours are no longer worth a Damn. I take it that this will not interfere with your LL.D. but leaves Walter in a very bad fix since he'll never be smart enough to know how many quarter hours he has.

It may be that I can spend the night with Dave tonight. If I do, you may be sure that we will say nice things about you.
