## Minutes of the Student Government Association March 2, 1999

**Call to Order:** Vice President Chad Lewis called the regular meeting of the Student Government Association to order at 5:05pm in the Congressional Chambers of the Downing University Center.

**Roll Call:** Vice President of Administration Matt Bastin called roll. **Minutes:** It was moved and seconded to suspend with the reading of the minutes. Motion approved.

**Officer Reports:** President, Stephanie Cosby – The President began her report by encouraging everyone to join Exec. tonight at BW3's to support the Toppers. Preston Center is also going to be open for popcorn, free sodas, and a large screen T.V. to watch the game. Anyone interested in a summer internship at Lost River Cave please see Stephanie. Ms. Cosby has a copy of the second "Big Red e-mail" if anyone is interested in reading it. Finally, this week is the Grad. Fair upstairs on the 3<sup>rd</sup> floor of D.U.C.

Executive Vice President, Chad Lewis – Chad reported that Provide-a-Ride use for last week was seventy-nine people.

Vice President of Finance, Ryan Morrison – Ryan announced that the previous account balance stood at \$21,195.86. Expenditures for the two weeks totaled \$525.94, which leaves the account balance as reported \$20,669.92.

Vice President of Public Relations, Cassie Martin – Anyone interested in helping the Vice President with the SGA webpage there is going to be a meeting tomorrow at 3:00pm in the SGA office. Cassie discussed the Auburn University trip and discussed the student health service there. the following pieces of legislation: Bill 99-7-S *Constitutional Amendment*, Bill 99-8-S *Constitutional Amendment*, and Bill 99-10-S *Bylaws Amendment*. The committee is continuing to look into sponsor more amendments for next week.

Public Relations – Amanda’s committee worked on a poster for the open forum. The also worked on getting information out about the SGA elections and ways to do that. The committee is changing their meeting times to 4:30 for the rest of the semester.

Student Affairs – The committee is working on three projects right now “Did you Know,” having a movie premier, and sponsoring of a SSW Conference.

Campus Improvements – Joe Morel gave the report for the committee. They discussed the new idea of having voice mail for all students on campus. They also discussed the suggestion boxes.

Mandy Coates asked why the spending limits were increased to \$500 dollars. Dwight Campbell made asked a question about section 2.8. Eddie Schwab made a motion to recess the meeting for fifteen minutes and it was seconded. Motion failed. VP of Administration Matt Bastin asked for a point of order; he noted that the constitution requires that twenty-four hour notice be given to justices before a meeting can be called. Adam Howard made a motion to postpone for a week and it was seconded. Motion failed. Section 5.1 was discussed. Dwight Campbell made a motion to defeat and it was seconded. Motion to defeat was approved by a vote of 25-0-9.

Bill 99-8-S *Constitutional Amendment* was read for first reading.


Bill 99-9-S *Constitutional Amendment* was read for first reading.
